WHEREAS, Idaho Code §34-302 requires the Board to establish suitable polling places for each voting precinct not less than 30 days prior to any election, and;

WHEREAS, Idaho Code §34-1006 requires the establishment of not less than one absent electors' polling place for each election.


NOW THEREFORE BE IT RESOLVED that the table attached hereto as Exhibit A, sets for the name of each precinct as well as the name of the building and physical location of each building to be used as a polling place, and;





MEMORANDUM

To: Commissioners

Re: Change in Designation of Polling Places for certain Precincts for the November 2nd, 2021 General Election and beyond, along with the remaining polling places for the balance of the precincts. This, in short, is co-locating seven (7) precincts, Airport, Baldy, Beach, Dover, Humbird, Washington, and Wrenco, at the Bonner County Fair Grounds, as several Sandpoint area facilities would like to get out of the business. It would also move Hope to the Clark Fork/ Hope Area Senior Center to be co-located with Clark Fork and Lakeview, and move Blue Lake, Laclede and Oldtown to the Priest River Event Center to be co-located with East Priest River and West Priest River.

Description: I.C. §34-302 requires the establishment of suitable polling places for each precinct at least 30 days prior to any election, and I.C. §34-1006 requires at least one absentee precinct established. This Resolution does these things.
