SOLE SOURCE PROCUREMENT BOCC

WHEREAS, Idaho Code 67-2808 provides that the Board of County Commissioners may, if it is found competitive solicitation is impractical, disadvantageous or unreasonable, acquire products in any manner the county deems best.

WHEREAS, Bonner County Board of Commissioners has determined that a competitive solicitation for pricing for a Fiber Optic Network is impractical, disadvantageous or unreasonable under these current market circumstances and that the procurement of the contract shall be a sole source purchase from Northwest Fiber, LLC dba Ziplly Fiber. The procurement shall have been published in the official newspaper of the political subdivision at least fourteen (14) calendar days prior to the award of the contract.


