Transfer of Funds

WHEREAS, Idaho Code Section 31-1605 provides that the Board of County Commissioners may adjust the budget, so long as there shall be no increase in anticipated property taxes; and

WHEREAS, the Bonner County Self-Insured Medical fund has insufficient cash due to medical and pharmacy claims exceeding employee and county collection of premiums; and

WHEREAS, Medical and pharmacy claims are difficult to foresee and are therefore funding throughout the year may either exceed or may be less than expenditures;

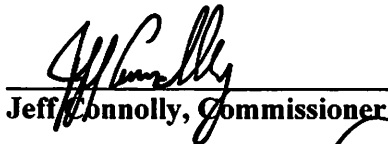
WHEREAS, unscheduled funds in the amount of up to \$150,000 has been identified as available to reduce the cash deficit.

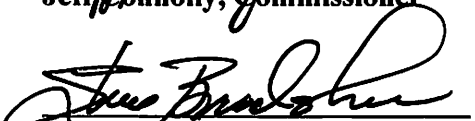

Re: Cash Transfer- ARPA Funds

Description:

At the beginning of FY2023, the Self-Insured Medical fund had a cash balance of \$0.00. Medical and pharmacy claims for the period ending November 15, 2022, has exceeded employer and employee contributions by \$66,832.67. Based on recent trends we do not foresee the claims decreasing in the short-term, thereby causing a continued cash deficit.

The Clerk's office is recommending a cash transfer of \$150,000.00 using ARPA funds in Fund 047 to offset the deficit through the end of October. Based on the county's selection of using ARPA funds as Revenue Replacement, these funds may be used for General Government Services.
