**ESTABLISHMENT OF ELECTION PRECINCTS
BY COUNTY COMMISSIONERS**

WHEREAS, Idaho Code §34-301 requires the Board to establish a convenient number of election precincts. The board shall have the authority to create new or consolidate established precincts only within the boundaries of legislative districts.

WHEREAS, Idaho Code §34-1006 requires the establishment of not less than one absentee elector polling place for each election which shall be located at the Elections Office in Suite 124 on the 1st floor of the Bonner County Administrative Office Building who's address is 1500 Highway 2 in Sandpoint Idaho





MEMORANDUM

To: Commissioners

Re: Establishment of Election Precincts by County Commissioners

Description: Idaho Code §34-301 requires the Board to establish a convenient number of election precincts. The Board shall have the authority to create new or consolidate established precincts only within the boundaries of legislative districts. Idaho Code §34-1006 also requires the establishment of not less than one absentee elector polling place for each election.

Discussion: Due to the results from the 2020 Census, the Idaho Secretary of State has finalized and released redistricting boundaries in Bonner County for the 2022 year and beyond. Legislative District #7 is being dissolved with those voters being moved into Legislative District #1. This will also dissolve the need for three of our precincts, Lakeview, Kelso, and Cocolalla precincts as they were only created to accommodate Legislative District #7. The voters from the Lakeview precinct will be moved into the Clark Fork precinct, voters from the Kelso precinct that are within Legislative District #1 boundaries will be moved into the Southside precinct, and voters from the Cocolalla precinct will be moved into the Southside precinct.

The redistricting results have created a Legislative District #2 in Bonner County that splits voters currently in Legislative District #1 in the Edgemere precinct. This creates the need for an additional precinct to accommodate Legislative District #2. Those voters affected in the Edgemere precinct will be moved into the newly created Clagstone precinct and will continue to vote at the Edgemere Grange Hall. A large portion of the Kelso precinct is now incorporated into Legislative District #2 and those voters affected will be moved into the Careywood precinct and will continue to vote at the Careywood Fire Station.

The absentee elector polling place will continue to be located at the Elections Office located in Suite on the 1st floor of the Bonner County Administrative Office Building whose address is 1500 Highway 2 in Sandpoint Idaho.



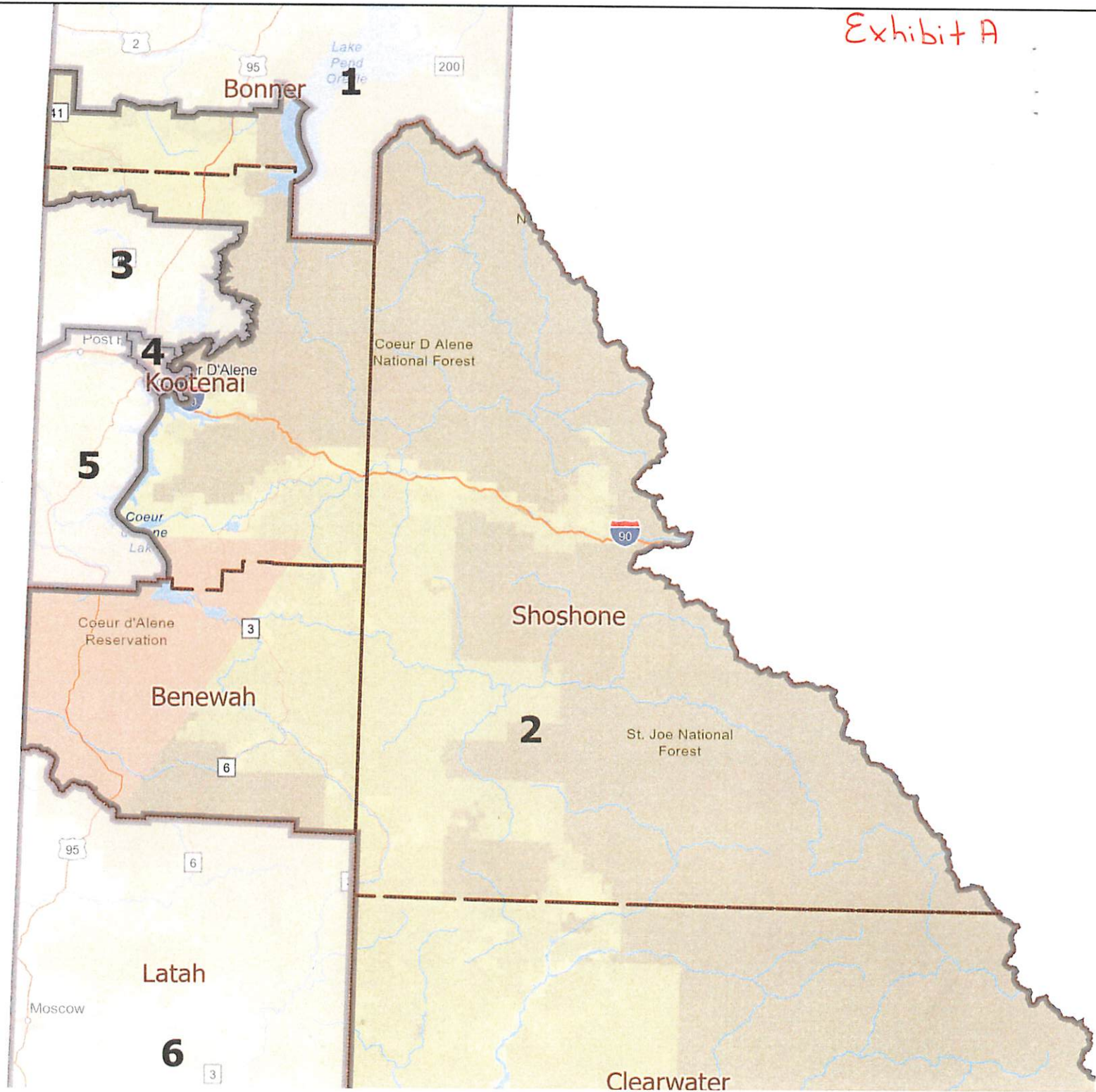

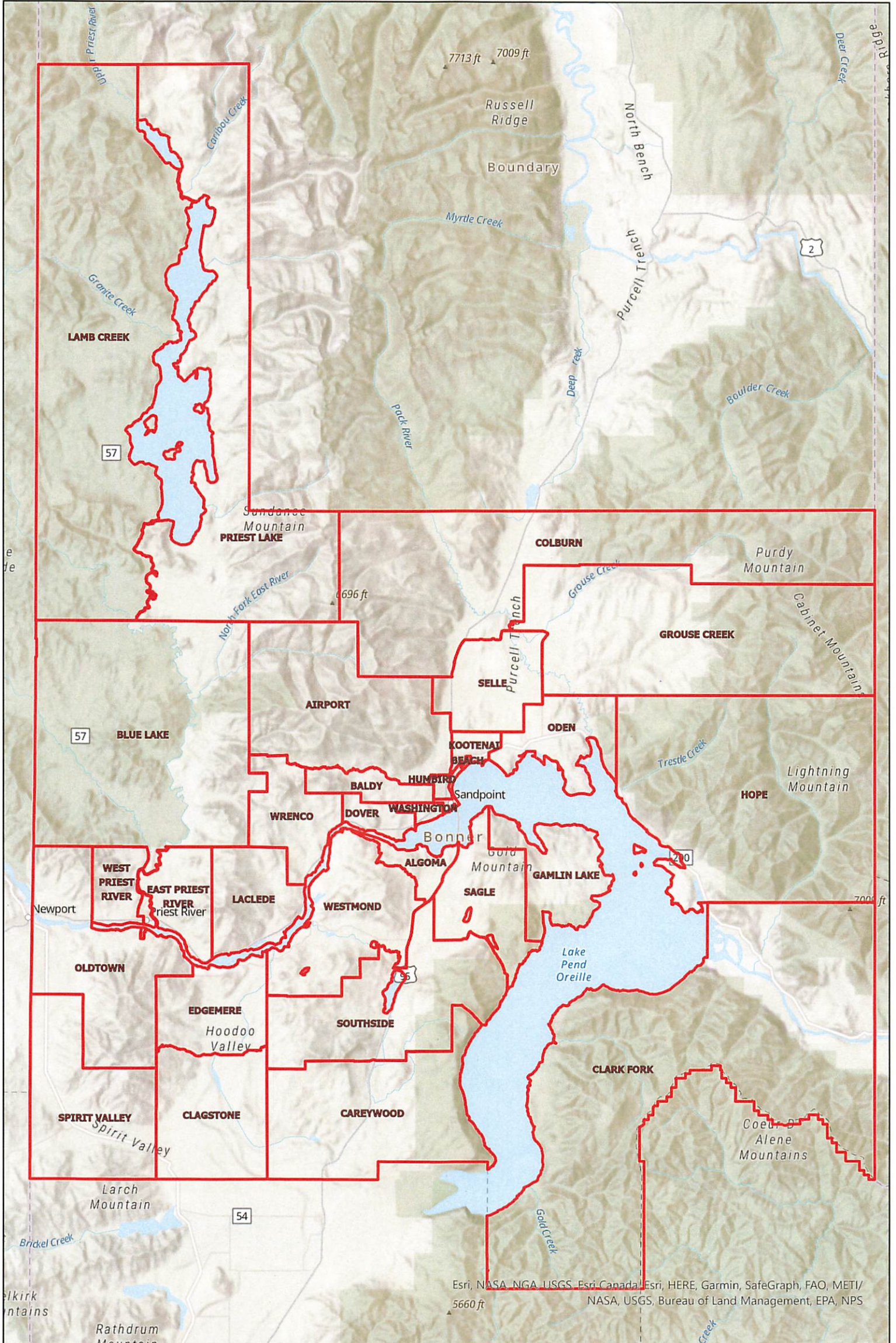
