Due to Unanticipated Revenue, increase Org 037 Object 7040, Vehicle Repair/Maintenance in the amount of \$4,801.27







Re: Bonner County Recreation received USFS Grant funds to be distributed between the Bonner County Marine Sheriff, Priest Lake Snowmobile and East Bonner Snowmobile departments. The Grant total was \$15,000.00 in which \$5,397.46 was given to the Marine Sheriff for reimbursement of enforcement and education. The remaining funds are to be distributed evenly between the two Snowmobile departments. Due to this Unanticipated Revenue, I am requesting authorization for the Clerk to open the Priest Lake Snowmobile budget and increase line item 036-7040 in the amount of \$4,801.27. I am also requesting the Clerk open the East Bonner Snowmobile budget and increase line item 037-7040 in the amount of \$4,801.27. These funds will be used for Vehicle Repair and Maintenance.
