**WHEREAS**, at the time of budgeting for FY 2022 the USDA Capital Improvements Loan had not yet been approved for construction costs and,



**ADOPTED** as a Resolution of the Board of Commissioners of Bonner County upon which a majority vote was had on the 26th day of July 2022.




