NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Bonner County, Idaho hereby authorizes the Clerk to open the budget and increase the following accounts:

03416-9030 Public Awareness in the amount of \$2000.00 from 4387.00 to \$6387.00


