



**Re:** Unanticipated Revenue – Use of ARPA Funds received



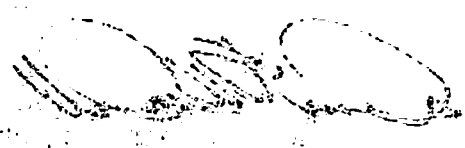
