**WHEREAS**, Bonner County received unscheduled revenue outside the annual budget procedure and without an increase in property taxes in 2021 or 2022, from the Idaho Office of Emergency Management Performance Grant (EMPG) award number 20EMPG024 to reflect these funds; and


**NOW, THEREFORE IT BE RESOLVED**, the Board of Commissioners of Bonner County, Idaho hereby authorize the Clerk to open the budget and schedule revenue by increasing Org 01110 object 7331 by \$12,856.51.

I would like these funds transferred into the Emergency Management FY22-23 budget Account 001-11-00-000-7331


