**ADOPTION OF THE
BONNER COUNTY
AND
BONNER COUNTY AMBULANCE DISTRICT
BUDGETS FOR FISCAL YEAR 2022-2023**

WHEREAS, the Board of Commissioners for Bonner County, Idaho has convened and considered said proposed budgets in detail and has made alterations allowable by law and which they deem advisable, and have agreed upon a tentative amount to be allowed and appropriated for the ensuing fiscal year to each office, department, service agency, or institution of the county as directed under Idaho Code §31-1604, and to include appropriations for all county leases, and;

WHEREAS, the county budget officer caused notice to be published setting forth the date, time and place that a public hearing for the purpose of taking comment on the proposed budgets, and;

WHEREAS, the county has new construction in the amount of \$803,689 and 3% in the amount of \$921,640 and;

WHEREAS, Bonner County Ambulance District has new construction in the amount of \$68,946 and 3% in the amount of \$79,430 and;

WHEREAS, such hearing was held on the 22nd day of August 2022 at 10:00 a.m. and again at 6:00 p.m. at 1500 Hwy 2, Sandpoint, Idaho.

NOW, THEREFORE, BE IT RESOLVED that after careful consideration of the testimony given at such public hearing, the Board of Commissioners for Bonner County, Idaho hereby approve and adopt the budget as published for Bonner County in the amount of \$81,133,014 for the fiscal year beginning October 1, 2022 and ending September 30, 2023; and

Approve and adopt the budget for Bonner County Ambulance District in the amount of \$7,030,193 for the fiscal year beginning October 1, 2022 and ending September 30, 2023.


