**INCREASE ADMINISTRATION FEE COLLECTED BY THE

WHEREAS, the Bonner County Board of Commissioners are authorized pursuant to Idaho Code § 31-870, Fees for County Services, to impose and collect fees by resolution; and

WHEREAS, such fees shall be in an amount reasonably related to but not exceeding the cost of services incurred by the Department of Motor Vehicles (DMV) ; and

WHEREAS, the County Assessor recommends an increase in the administration fees collected by the DMV from the current fees of \$6.50 to \$9.50 effective October 1, 2022, to cover the increased operating costs incurred by DMV; and

WHEREAS, in accordance to § 63-1311A, a Notice was published in the Bonner County Daily Bee August 17th & August 24th, 2022.




