WHEREAS, Bonner County Planning Department receives fees for building location permits; and


WHEREAS, the Planning Department has received unexpected additional revenue in the amount of \$40,000.00 from Building Location Permit Fees and \$20,000 in Stormwater/Erosion Control; and

WHEREAS, the Planning Department requests the additional revenue be placed in Planning Department FY2022 Budget A \$40,000.00 and Budget B \$20,000;


NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Bonner County, Idaho hereby orders the Clerk to open up the budget in the Planning Department FY2022 Budget A, Org 00123 object 6060 in the amount of \$40,000.00 and Budget B, Org 00123 Object 7860 in the amount of \$20,000; this adjustment is due to the receipt of unanticipated Building Location Permit Fee and Stormwater/Erosion Control revenue.

Adopted as a Resolution of the Board of Commissioners of Bonner County, Idaho the 6th day of September, 2022.


