Budget Transfer from Salaries "A" to Current Expenses "B"

WHEREAS, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes; and,


WHEREAS, the Bonner County Jail has positions currently not filled in the "A" Budget, allowing for an overage, and;


WHEREAS, this overage can be used to cover the unanticipated costs of medical supplies, inmate medical bills, inmate meals and fuel.


NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Bonner County authorizes the Clerk to open the Jail "B" budget and increase line item 03461-7860 Misc. Expenses by \$27,000.00 and reduce line 03478-6020 by \$27,000.00.

ADOPTED as a Resolution of the Board of Commissioners of Bonner County upon a majority vote on the 20th day of Sept., 2012.


