

**RESOLUTION NO. 22-75
PLANNING COMMISSION**

**Appointing Michael Leita to the
Bonner County Planning Commission**

WHEREAS, Idaho Code 67-6504 provides the authority for creation of a Planning Commission and procedures for filling vacancies; and

WHEREAS, the Bonner County Board of Commissioners has created a Planning Commission with the adoption of Ordinance 655 thereby amending Bonner County Revised Code Section 12-123 providing for the creation of a Planning Commission and procedures for filling vacancies and terms of office thereon; and

WHEREAS, Bonner County Revised Code Section 12-122 provides for the creation of the Bonner County Planning Commission with seven (7) positions with the terms of office as set forth: Positions A, B, and C shall first expire September 30, 2025, and then every three (3) years thereafter. Positions D and E shall expire September 30, 2024, and every three (3) years thereafter. Positions F and G shall expire September 30, 2023, and every three (3) years thereafter; and

WHEREAS, position E is now a vacant in the Planning Commission; and

WHEREAS, the Chair of the Board of County Commissioners has submitted to the Board Michael Leita to the Planning Commission;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Bonner County, Idaho, of the appointment of Michael Leita as a Commission Member of the Bonner County Planning Commission to fill the position effective today September 23, 2022. Adopted as a resolution of the Bonner County Board of Commissioners upon a majority vote this 23rd day of September 2022.

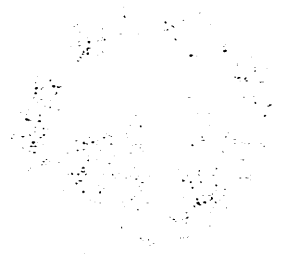
