**Budget Transfer from Capital "C" to Current Expenses "B"**

WHEREAS, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes; and,

WHEREAS, the Bonner County Sheriff's Office has funds currently not utilized in the "C" Budget, allowing for an overage, and;


WHEREAS, this overage can be used to cover the unanticipated costs of fuel, cellphones, equipment and office supplies.


NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Bonner County authorizes the Clerk to open the Sheriff's "B" budget and increase line item 03450-7860 Misc. Expenses by \$27,974.00 and reduce line 03472-9350 by \$10,497.00 Capital-Lease Expenditure and 03472-9390 by \$17,477.00 Capital-Vehicles.
