RESOLUTION # 23- 5

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BONNER COUNTY, IDAHO APPOINTMENT OF PUBLIC DEFENDER

WHEREAS, Idaho Code § 19-859 authorizes the Bonner County Board of Commissioners to establish and maintain an office of the Public Defender; and

WHEREAS, the Board of County Commissioners of Bonner County, Idaho, desires to appoint Luke Hagelberg as the Bonner County Public Defender; and

WHEREAS, in accordance with Idaho Code § 19-860(1), the annual compensation given the duties required of a Public Defender shall be at an annual rate not less than the compensation paid to the County Prosecutor for that portion of his practice devoted to criminal law; and


WHEREAS, the Public Defender shall be required to devote full-time to the discharge of her duties during her tenure in the office; and


WHEREAS, to the extent permitted by Idaho Code §19-860, the Public Defender shall serve at the pleasure of the Board of County Commissioners.

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Bonner County, Idaho, that Luke Hagelberg be appointed as the Bonner County Public Defender effective January 26, 2023, with the annual salary not less that the compensation paid to the County Prosecutor for that portion of his practice devoted to criminal law, and she shall devote full-time to the discharge of her duties during her tenure in the office, and shall service at the pleasure of the Board of County Commissioners.

DULY ADOPTED as a Resolution of the Board of County Commissioners of Bonner County, Idaho, done this 26th day of January, 2023.


