NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Bonner County, Idaho, of the appointment of Matt Linscott as a Commission Member of the Bonner County Planning Commission to fill the position effective today February 7, 2023. Adopted as a resolution of the Bonner County Board of Commissioners upon a majority vote this 7th day of February 2023.
