NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Bonner County, Idaho hereby orders the Clerk to move revenue currently held in Probation Services FY22-23 budget, to Account No. 006-00661-7430 Repairs & Maintenance Buildings/Fixtures/Grounds in the amount of \$3,945.02 from \$58,655.00 to \$62,600.02. This adjustment is due to the receipt of unanticipated Lottery Tax revenue received from the State of Idaho.
