NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Bonner County, Idaho, of the appointment of Jake Weimer as a Commission Member of the Bonner County Zoning Commission to fill the position effective today March 21, 2023. Adopted as a resolution of the Bonner County Board of Commissioners upon a majority vote this 21st day of March 2023.
