WHEREAS, Idaho Code Section 31-1605 provides that the Board of County Commissioners may adjust the budget, so long as there shall be no increase in anticipated property taxes; and

WHEREAS, the Bonner County has recently been notified that the County property located at 71 Eastside Road, housing DMV, Sheriff's Office personnel Road & Bridge, that gas will no longer be provided to the building due to natural gas compliance issue; and

WHEREAS, none of the abovementioned departments have budgeted for such an unexpected expense; and


WHEREAS, it is the desire of the Board of County Commissioners to swiftly solve this issue and recommend the transfer of \$60,657 of unencumbered interest earnings from ARPA funds to fund 002-7860 for the repairs necessary to regain NFPA compliance; and

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Bonner County, Idaho hereby authorizes the Clerk to transfer of \$60,657 of unencumbered interest earnings from ARPA funds to fund 002-7860, Road & Bridge, Miscellaneous Expenses



Memorandum

Re: Complete repiping of the District 2 Road and Bridge Shop to meet NFPA standards (National Fuel Gas Code)

On May 8, 2023 AmeriGas ceased providing propane to the District 2 Road and Bridge Shop in Priest River, Idaho; this facility also houses the Priest River DMV and BCSO substation. AmeriGas will not allow a pressure higher than 5 psi without the explicit endorsement of Idaho State Fire Marshall.

Bonner County Road and Bridge received a bid from Pend Oreille Mechanical to address the deficiency for \$60,657, this bid is good for 30 days and requires 50% due upon acceptance and 50% upon completion of the job. This work is required for this facility to operate safely.
