Donation of County Property to the United States Forest Service

WHEREAS, pursuant to IC 31-808(9) and IC67-2322, the Board of County Commissioners may at their discretion, grant to or exchange with the federal government, the state of Idaho, any political subdivision or taxing district of the State of Idaho, with or without compensation, any personal property owned by the county when it is in the best interest of the public in the judgment of the governing body of the granting unit; and

WHEREAS, Bonner County Facilities has not utilized these snow blowers in almost five years, no annual maintenance has been performed, when used there were multiple mechanical issues. The USFS will be able to perform the maintenance to get them in better working order, they also have an area that is better suited for the size of these machines. These types of transfers also create goodwill between agencies in Bonner County; and

WHEREAS, it has been determined that it would be in the public's best interest to grant the two (2) Snow Beast 45" Snow blowers to the United States Forest Service.



ADOPTED as a Resolution of the Board of County Commissioners of Bonner County, Idaho upon a majority vote on the 13th day of June, 2023.



Bonner County Facilities has two (2) Snow Beast 45" Snow blowers that are impractical and used very little for snow removal because of the size and maneuverability of the machines.


