

**RESOLUTION NO. 23 - 51**

**SOLID WASTE  
SOLID WASTE DISPOSAL FEES**

**WHEREAS** Bonner County operates a solid waste disposal system pursuant to the provisions of Idaho Code Title 31 Chapter 44; and

**WHEREAS** Idaho Code 31-4403 requires the Board of County Commissioners in each county to acquire sites or facilities, and maintain and operate a solid waste disposal system; and

**WHEREAS** Idaho Code 31-4404 provides that each county may finance solid waste disposal facilities by user fees, taxes or other appropriate charges.

**BE IT FURTHER RESOLVED**, by the Bonner County Board of Commissioners, that the following amendment is hereby established:

RESIDENTIAL

1. That all property owners who pay the required \$185.00 or the amount charged to them from Schedule B shall be issued two (2) facility stickers for each solid waste fee applied. Landlords are responsible to distribute the issued stickers to their tenants. These stickers must be used in order to dispose of debris at the Bonner County Solid Waste facilities. Residents requiring more than two (2) stickers may purchase up to ten (10) additional stickers at the cost of \$5.00 each.

**APPROVED THIS** 21st day of June 2023, as a Resolution of the Bonner County Board of Commissioners.



**SOLID WASTE FEE SCHEDULE**

Effective 6/21/2023 as per Resolution 23-\_\_\_\_

**RESIDENTIAL**

Customers with a solid waste sticker may dispose of up to three (3) yards per day at no charge, any overage will be charged at the posted commercial rates (see below). The annual solid waste fee is \$185.00 per occupiable dwelling unit.

Bonner County residential customers without a sticker pay a \$5.00 fee to dispose of up to three (3) yards per day; over three (3) yards will be charged at the posted commercial rates.

Only waste generated in Bonner County will be accepted at the Bonner County Solid Waste facilities.

**RESIDENTIAL IN COUNTY FEES**

Annual Solid Waste Fee	\$185.00 per year up to 3yds per day
Over 3yds	\$ 18.00 per yard
Extra Sticker	\$ 5.00 each
No Sticker	\$ 5.00 minimum for first 3yds per day
Each additional yard	\$ 18.00 for each additional yard

**Appliances with freon (i.e.: refrigerator, freezer)**

First unit	\$ No decommissioning fee
Additional Refrigeration units	\$ 30.00 decommissioning fee per unit

\*Note any commercial style refrigerator will be charged a \$30.00 decommissioning fee

Passenger auto or pickup up to 22 inches	First 4 tires no fee (per day)
Additional Tires	\$ 2.00 each
Additional Tire w/rim	\$ 5.00 each
Large truck tires (Semi/Trailer)	First 2 tires no fee (per day)
Additional Large Tires	\$ 10.00 each
Additional Large Tire w/rim	\$ 20.00 each
Oversized (skidder or farm tractor)	First tire no fee (per day)
Additional oversize tire	\$ 50.00 each
Additional Tire w/rim	\$ 125.00 each
Animal carcass less than 100 lbs.	\$ No charge
Animal carcass 100 lbs. or over	\$ 10.00 each

**Televisions/Monitors**

Television/Monitor	First television no fee (per day)
Additional Tire/Monitor	\$ 5.00 each

**HOUSEHOLD HAZARDOUS WASTE 10 GALLONS PER COLLECTION EVENT AND MUST PRESENT SOLID WASTE STICKER.**

**COMMERCIAL**

Solid Waste reserves the right to determine if a load is acceptable and apply the cost to process the debris if there is a question as to content, weight, and/or amount. Certain types of debris or hazardous materials may be referred to another facility.

Minimum charge on ½ yard or less \$ 9.00 PER ½ cubic yard or less  
Inert (Colburn-Dickensheet-Idaho Hill) \$ 10.00 per cubic yard

Commercial waste \$ 18.00 per cubic yard  
Commercial waste by weight \$120.00 per ton (\$0.06 per lb.)

Televisions under 75 lbs., computer monitors \$ 10.00 each  
Televisions over 75 lbs. \$ 25.00 each

LED televisions and rear projection televisions are not recyclable and are to be placed into the normal waste stream.

**Tires:**

Passenger auto or pickup up to 22 inches \$ 2.00 each / with rim \$5.00 each  
Large truck tires (Semi/Trailer) \$ 10.00 each / with rim \$20.00 each  
Oversized (skidder or farm tractor) \$ 50.00 each / with rim \$125.00 each

Refrigerators / Freezers \$ 30.00 decommissioning fee per unit

Metal: \$ 10.00 per yard  
Wood/Brush (All sites) \$ 18.00 per yard  
Recycling/Cardboard \$ 18.00 per yard

Bonner County does not accept commercial hazardous waste.
