**WHEREAS**, the Board of Commissioners for Bonner County, Idaho has convened and considered said proposed budgets in detail and has made alterations allowable by law and which they deem advisable, and have agreed upon a tentative amount to be allowed and appropriated for the ensuing fiscal year to each office, department, service agency, or institution of the county as directed under Idaho Code §31-1604, and to include appropriations for all county leases, and;

**WHEREAS**, the county budget officer caused notice to be published setting forth the date, time and place that a public hearing for the purpose of taking comment on the proposed budgets, and;

**WHEREAS**, the county has new construction in the amount of \$604,244 and \$3% in the amount of \$973,383 and;

**WHEREAS**, EMS has new construction in the amount of \$49,774 and \$3% in the amount of \$83,873 and;

**WHEREAS**, such hearing was held on the 21st of August 2023 at 10:00 a.m. and again at 6:00 p.m. at 1500 Hwy 2, Sandpoint, Idaho.




