Re: Resolution for Jail A to C Fund Transfer

The Jail has positions currently not filled in the "A" Budget allowing for an overage. A resolution is being submitted with a request to transfer \$152,000.00 from the "A" Budget to the "C" Budget. This amount will cover the emergency replacement of the cracked and damaged Heating and Air Conditioning Units.

The replacement of the cracked and damaged Heating and Air Conditioning Units would be considered an emergency expenditure line item under I.C. 67-2808(1)(a)(iii) with a motion to declare a property safeguard emergency as a precondition for the immediate purchase of the goods/services.

I.C. 76-2808(1) Emergency expenditures.

- (a) The governing board of a political subdivision may declare that an emergency exists and that the public interest and necessity demand the immediate expenditure of public money if:
- (iii) It is necessary to do emergency work to safeguard life, health, or property.
- (b) Upon making the declaration of emergency, any sum required in the emergency may be expended without compliance with formal bidding procedures.
