
WHEREAS, Frank Gurney Inc has started the project in fiscal year 2023 and will not be completed until Mid-October fiscal year 2024

WHEREAS, These funds are needed to complete this project in fiscal year 2024.





Re: Road and Bridge Budget – Transfer of funds from FY 2023 to FY 2024

Idaho code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes.

Bonner County entered into an agreement with Frank Gurney Inc, to place 517 feet of guardrail along Bear Paw Road for the sum of \$34,321.00 On August 29th, 2023 as approved by the commissioners on this date.

Where this project has been started and will be finished in October 2023 FY 24 and Funds were to come from FY 23 ,002-8552 Guardrail in the amount of \$20,704.00 and from 002-8551 Bridge repairs in the amount of \$13,617.00
