


**WHEREAS**, these payments of unanticipated revenue could be used to help with the Whiskey Jack / West Oden Bay connection project

The foregoing was duly enacted as a Resolution of the Board of County Commissioners of Bonner County, Idaho, on this 3rd day of October 2023.


