MEMORANDUM

To: Commissioners

Re: Budget Funds Transfer Resolution

Description: This resolution will transfer funds within the Airports budget to enable the purchase of a replacement vehicle.

You may know that much of the equipment used to maintain our airports is old and well-used. This is particularly true of our 2008 3/4-ton pickup which was a hand-me-down from Solid Waste years ago. Last week this truck came back from the repair shop with an estimate for necessary and recommended repairs that far exceed the value of the truck. This type of truck is essential to our year-round operations at both airports.

I spoke to Jason at Road and Bridge to see if he had anything he might be able to hand-down, but he does not. I then spoke to Teddi in Purchasing and she directed me to Bob Howard for truck purchases. I told Bob what we needed, and he came back to me yesterday with three options, the best of which is a used truck recently traded-in to Taylor & Sons here in town and available at a good price.

We have money in the airports budget to purchase this truck due to a combination of unanticipated revenue from a recent timber sale and by deferring a small amount of discretionary pavement maintenance.

It is in the public interest for us to purchase this truck for continued airport safety, maintenance, and to transport crew and equipment between airports.
