

RESOLUTION NO. 24 - 45

SOLID WASTE SOLID WASTE DISPOSAL FEES

WHEREAS Bonner County operates a solid waste disposal system pursuant to the provisions of Idaho Code Title 31 Chapter 44; and

WHEREAS Idaho Code 31-4403 requires the Board of County Commissioners in each county to acquire sites or facilities, and maintain and operate a solid waste disposal system; and

WHEREAS Idaho Code 31-4404 provides that each county may finance solid waste disposal facilities by user fees, taxes or other appropriate charges.

BE IT FURTHER RESOLVED, by the Bonner County Board of Commissioners, that the following amendment is hereby established:

RESIDENTIAL

1. Residential solid waste disposal fees shall be calculated as set for in the attached "Schedule A" and will be effective September 1, 2024.
2. A residential solid waste disposal fee in the amount of \$194.00 per year is hereby established for each occupiable dwelling unit in Bonner County.
3. All property owners who pay the required \$194.00 charged to them from "Schedule A" shall be issued two (2) facility stickers for each solid waste fee applied.
4. Landlords are responsible to distribute the issued stickers to their tenants.
5. Stickers must be used in order to dispose of up to three (3) yards per day of debris at Bonner County Solid Waste collection facilities.
6. Residents requiring more than two (2) stickers may purchase up to eight (8) additional stickers at the cost of \$5.00 each.
7. Residents applying for solid waste stickers will be charged \$194.00. Stickers are valid for a calendar year; from January 1st to December 31st. Stickers purchased as of July 1st or later will have an adjusted rate of \$97.00.
8. Any household qualifying for "Property Tax Reduction" relief on their property tax bill shall be billed in accordance with the attached "Schedule B" which is hereby incorporated into this Resolution in its entirety.


9. Stickers are for the disposal of household trash only and are not to be used for any commercial disposal. (See commercial section below)
10. Use of an unattended site without a sticker shall be classified as a violation and will be subject to the penalties as described in Bonner County Solid Waste Ordinance 212.
11. Bonner County Solid Waste is responsible for determining if a load is acceptable. Certain types of debris or hazardous materials may be referred to another facility.

COMMERCIAL

1. Commercial solid waste disposal fees shall be calculated as set forth in the attached "Schedule A" and will be effective September 1, 2024.
2. As per Bonner County Code Title 7-202 and the Idaho Constitution, Article XII Section 4, a county approved solid waste disposal and collection system must be used by all commercial, non-profit and Public entities.
3. All commercial, non-profit and public establishments in Bonner County including but not limited to motels, hotels, resorts, automobile repair garages, churches, schools, office buildings, recreational vehicle parks, restaurants, campgrounds, bars, grocery stores, gas stations, retail stores and commercial buildings shall have their municipal waste collected by an authorized commercial hauler. The frequency of collection for commercial and public establishments shall be such that the public health hazard or nuisance does not result. (Ord. 202,1-9-1992)
4. Mobile/RV parks in Bonner County must arrange with the current waste disposal contract holder, a collection system that is suitable to the size and number of spaces within their park.
5. Bonner County Solid Waste is responsible for determining if a load is acceptable. Certain types of debris or hazardous materials may be referred to another facility.
6. All commercial fees billed pursuant to this Resolution shall be due and payable within thirty (30) days. Past due accounts will be subject to suspension and/or cancellation.



SOLID WASTE FEE SCHEDULE
Effective 9/1/2024 as per Resolution 24-____

RESIDENTIAL

Customers with a solid waste sticker may dispose of up to three (3) yards per day at no charge, any overage will be charged at the posted commercial rates (see below). The annual solid waste fee is \$194.00 per occupiable dwelling unit.

Bonner County residential customers without a sticker pay a \$5.00 fee to dispose of up to three (3) yards per day; over three (3) yards will be charged at the posted commercial rates.

Only waste generated in Bonner County will be accepted at Bonner County Solid Waste facilities.
