**WHEREAS**, by Resolution 18-76 the office of the Bonner County Commissioners formed the Bonner County Airport Advisory Board;


**WHEREAS**, the board consists of seven members; and



Duly enacted as a Resolution of the Board of County Commissioners of Bonner County, Idaho, on the 20<sup>th</sup> day of August, 2024.


