Carry Forward Funds for the Sheriff's Office Complex Fence

Add Carry Forward Funds to FY2025 "B" Budget

WHEREAS, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes; and,

WHEREAS, on September 17th, 2024 Bonner County Commissioners approved the fencing purchase for the Bonner County Sheriff's Office Complex from Idaho Fence; and,

WHEREAS, Bonner County has obligated these funds for this project and the project has been started in Fiscal 2024 and will be finished in Fiscal 2025; and,


WHEREAS, the Sheriff's Office will need these funds to complete this transaction for this contractual obligation.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Bonner County authorizes the Clerk to open the FY25 budget and increase 00822/7860 Dispatch/Misc expenses \$3,220.00, 03461/7420 Detention/Rep Equip \$5,557.52, 03461/7860 Detention/Misc \$3,500.00, 03450/7430 Sheriff/Rep Bldgs \$24,000.00, 03450/7860 Sheriff/Misc. \$4,249.76 with all combined object lines totaling \$40,527.28.

ADOPTED as a Resolution of the Board of Commissioners of Bonner County upon a majority vote on the 22 day of October, 2024.



On September 17th, 2024 Bonner County Commissioners approved the fencing purchase for The Bonner County Sheriff's Office complex from Idaho Fence for \$40,527.28. Funds are to come from 00822/7860 Dispatch/Misc expenses \$3,220.00, 03461/7420 Detention/Rep Equip \$5,557.52, 03461/7860 Detention/Misc \$3,500.00, 03450/7430 Sheriff/Rep Bldgs \$24,000.00, 03450/7860 Sheriff/Misc. \$4,249.76.

Whereas this project has been started and will be finished in November fiscal year 2025 and The Sheriff's Office will need this obligated funding to pay for this project.

The Sheriff's Office requests the Commissioners authorize the Clerk to open the FY2025 budget and add \$40,527.28 from the fiscal 2024 line items outlined as follows 00822/7860 Dispatch/Misc expenses \$3,220.00, 03461/7420 Detention/Rep Equip \$5,557.52, 03461/7860 Detention/Misc \$3,500.00, 03450/7430 Sheriff/Rep Bldgs \$24,000.00, 03450/7860 Sheriff/Misc. \$4,249.76 as detailed in the attached resolution.
