WHEREAS, the Justice Services Department requests the additional revenue in the Juvenile Detention FY23-24 Budget, Revenue Account No. 03475-4990 – JUVENILE DETENTION BILLING for use as additional funding for Juvenile Detention FY24-25 Budget, Account No. 03475-7430 – REPAIRS/MAINT-BLDGS/FIXTRS.
