**Appointing a Member to the
Bonner County Agriculture Protection Area Commission**

WHEREAS, Idaho Code 67-9705 provides the authority for creation of an Agriculture Protection Area Commission and procedures for filling vacancies; and

WHEREAS, the Bonner County Board of Commissioners has created an Agriculture Protection Area Commission with the adoption of Ordinance 718 thereby establishing Bonner County Revised Code Section 16-201 providing for the creation of an Agriculture Protection Area Commission and procedures for filling vacancies and terms of office thereon; and

WHEREAS, Bonner County Revised Code Section 16-201 provides for the creation of the Bonner County Agriculture Protection Area Commission with three (3) positions with the terms of office as set forth: Position A shall first expire December 31, 2025, and then every three (3) years thereafter. Position B shall expire December 31, 2026, and every three (3) years thereafter. Position C shall expire December 31, 2027, and every three (3) years thereafter. Positions A, B, and C are vacant; and

WHEREAS, the Chair of the Board of County Commissioners has submitted to the Board the following to be appointed:


Erin Roos – Position A; Ron Fridlund – Position B; and Dan Elliott – Position C.



Adopted as a resolution of the Bonner County Board of Commissioners upon a majority vote this 18th day of March, 2025.


