WHEREAS, Bonner County Solid Waste is in possession of the following vehicles; a 2016 Ford F350 VIN# 1FT8X3BT4GEB43294 that includes a 8' 2yard Briggs sander Serial #17083120675099032-1 and a 2017 Ford F350 VIN#1FT8X3BT0HEC10927; **and**

WHEREAS, it is the desire of Bonner County Solid Waste to have these vehicles and sander declared as surplus to their operations and is no longer needed; **and**

WHEREAS, in accordance with Idaho Code Title 31 Chapter 8, the Board of County Commissioners determined that it would be in the best interest of the citizens of Bonner County to declare these vehicles and sander surplus and sell at auction;

NOW, THEREFORE, BE IT RESOLVED that the following vehicles: a 2016 Ford F350 VIN# 1FT8X3BT4GEB43294 that includes a 8' 2yard Briggs sander Serial #17083120675099032-1 and a 2017 Ford F350 VIN#1FT8X3BT0HEC10927 be declared as surplus as they are no longer needed. After motion and unanimous decision of the Board of County Commissioners, said equipment shall be declared as surplus and sold at auction.

ADOPTED as a Resolution of the Board of Commissioners of Bonner County upon a majority vote on the 5th day of May 2026.


