**ADOPTION OF THE
BONNER COUNTY
BUDGETS FOR FISCAL YEAR 2026-2027**

WHEREAS, the Board of Commissioners for Bonner County, Idaho has convened and considered said proposed budgets in detail and has made alterations allowable by law and which they deem advisable, and have agreed upon a tentative amount to be allowed and appropriated for the ensuing fiscal year to each office, department, service agency, or institution of the county as directed under Idaho Code §31-1604, and to include appropriations for all county leases, and;

WHEREAS, the county budget officer caused notice to be published setting forth the date, time and place that a public hearing for the purpose of taking comment on the proposed budgets, and;

WHEREAS, the county has new construction yielding \$527,075 in new levy ability, and 3% in the amount of \$1,121,241 and;

WHEREAS, the county has forgone in the amount of \$4,866 and;

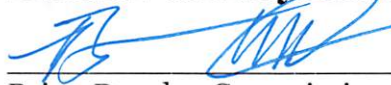
WHEREAS, the county's levy from all the above total \$38,453,667 and;

WHEREAS, such hearing was held on the 31st day of August 2026 at 10:00 a.m. and again at 6:00 p.m. at 1500 Hwy 2, Sandpoint, Idaho.

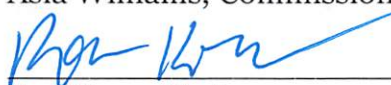
