Budget Transfer from Operating "B" to Capital "C"

WHEREAS, the Bonner County Sheriff's Office needs replacement repeaters, and;

WHEREAS, the funds are available in the "B" Budget.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Bonner County authorizes the Clerk to open the 911 Repeater "C" budget and increase line item 00824-9410 Capital/Communications Equipment by \$33,000.00 and reduce line 00824-7110 911 Repeaters Prof Serv/Other by \$33,000.00.

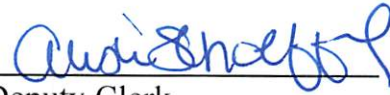
