**WHEREAS**, Idaho Code §31-1605 provides that the Board of County Commissioners may adjust the budget as adopted to reflect the receipt of unscheduled revenue, grants or donations from federal, state or local governments or private sources, provided that there shall be no increase in anticipated property taxes, and;


**WHEREAS**, Bonner County Weeds has received unscheduled revenue for reimbursement of weed control work in the amount of \$899.00 from the Pack River Floodplain Revegetation Project through the U.S. Department of Fish & Wildlife, Grant #F16AC00500, via Bonner County Recreation, and;


**WHEREAS**, It would be in the best interests of Bonner County Weeds to utilize the herbicide portion of this reimbursement during FY2020---\$400.00 was for herbicides, \$499.00 was for labor and;



Bonner County obtained a grant from the U.S. Department of Fish & Wildlife, via the Recreation Department, for the Pack River Floodplain Revegetation Project. The Weeds Department performed weed control work as part of the project in cooperation with the Recreation Department.


Requesting that the Commissioners approve opening the FY20 Weeds budget and authorize the Clerk to transfer \$400.00 from 027-5670 Miscellaneous Revenue, to 027-8390 Herbicides. The reimbursement to Weeds was in the amount of \$899.00 and deposited into the Miscellaneous Revenue account--\$400.00 was for the herbicide cost and \$499.00 was the total for the labor. Idaho Code §31-1605 provides for budget adjustment provided that there is no increase in anticipated property taxes.
