Purpose/Topic Summary (required): Canvas of the Election

Chairman Kelly opened the meeting to Canvas the Election.

Michael Rosedale spoke on the following items:

- This was a paper ballot only with manual counting done at the local precincts.
- Only 21 of 33 precincts had a question.
- The pre-election training went very well, and I think we've discovered a far more effective way to train the poll workers (Q&A, Power Point examples), better labels on boxes, etc.
- 24 contests/ questions.
- Only 1 close race (1/vote): Hope City Council.
- As you can see, all five pages of abstracts are before you. The 6<sup>th</sup> page contains the voting stats.
- All races w/in 5 votes will be eligible for a free recount if party requests it.
- 3 Ballot Questions:
  - Priest River Sewer Revenue Bond - Passed (simple majority required)
  - Sandpoint 1% Sales Tax - Passed (60% required)
  - West Priest Lake FD - FAILED (2/3<sup>rd</sup> required)
- One precinct anomaly which was corrected. They used the tally book numbers incorrectly and so were 10 votes overstated. (which did not affect any race)
- The average voter turnout was low...around 24%. The precincts in the city of Sandpoint had predictably higher turn outs...up to 53%.

Charlie Wurm went through the abstract which was provided to the Board for review. The totals were called in by the poll workers, then their numbers were checked.

The Commissioners confirmed and approved the Canvas of the Election.
