## Bonner County Justice Services PREA Annual Report For 2023

The Bonner County Juvenile Detention Center fully supports the Prison Rape Elimination Act of 2003 (PREA). For years Bonner County Detention Center has trained staff and residents on prohibited contact and inappropriate relationships to prevent the problem of sexual abuse within its walls.

The reporting of any type of sexual abuse in the Bonner County Juvenile Detention Center is extremely low, with all reports being unfounded or unsubstantiated. In the calendar year of 2023, we had zero reports of sexual abuse and zero reports of harassment, either resident on resident or staff on resident. However, we realize that we must continue our efforts to combat sexual abuse constantly. We will continue to hold strong to a Zero Tolerance policy. Should the need for an investigation occur we will use that information to determine if changes need to be made to existing policy and procedures, facility characteristics, staffing schedules, personnel assignments and supervision.

During the last year all detention staff, volunteers, and contractors have received PREA training. The residents also receive PREA education at least weekly. In conjunction with training and education, high levels of supervision are the main tools used to prevent sexual abuse or any other incidents within the facility.

The PREA Standards contain 182 separate standards organized in over 40 sections. Each of the individual standards often contains multiple requirements.

Bonner County Juvenile Detention Center scheduled it's third ever PREA audit and it was held May 16 through the 19<sup>th</sup> of 2022. The result was a brief corrective action on a few policies which was completed. We are currently in compliance with the Prison Rape Elimination Act of 2003(PREA).
