# **Introduction**

Idaho Code §67-6508 (H) requires the following for the Public Services, Facilities, and Utilities Component:

An analysis showing general plans for sewage, drainage, power plant sites, utility transmission corridors, water supply, fire stations and firefighting equipment, health and welfare facilities, libraries, solid waste disposal sites, schools, public safety facilities and related services. The plan may also show locations of civic centers and public buildings.

# Chapter 1 – Sewage Disposal

## Section 1.1 – Overview

Jurisdictional authority for sewage disposal in Bonner County is the responsibility of two agencies: the Panhandle Health District and the Idaho Department of Environmental Quality (DEQ). According to the Memorandum of Understanding between the two agencies, the Panhandle Health District is responsible for reviewing and permitting all subsurface sewage disposal systems. Developments that create a need for subsurface sewage disposal should contact Panhandle Health District.

The records for all subsurface sewage systems are found at Panhandle Health District. See [Figures 1 through 8](#) and [Figures 13 through 24](#) for a map of each sewer tax district and water & sewer tax district. The capacity and availability of the current sewer tax districts, and water & sewer tax districts is limited to the design capacity of the given system; however, the systems may expand subject to DEQ and Panhandle Health District review and approval. Capacity of shared systems should be considered when used to determine uses and residential densities.

There are several central sewer systems in Bonner County. The Idaho Department of Environmental Quality regulates the design, construction, and operation of sewer systems and their facilities under the Idaho Wastewater Rules (IDAPA 58.01.16). Disposal of treated sewer effluent to surface water or its use as recycled water requires a DEQ permit. Developments needing to connect to an existing sewer system should first contact the sewer purveyor. Any development requiring a new sewer system should contact DEQ.

## **Chapter 2 – Water Suppliers**

### **Section 2.1 – Private Water Suppliers (non-regulated)**

Private water systems utilize wells springs or surface water sources. Private water supplies are the sole responsibility of the system owner(s) to maintain and to ensure safe drinking water. These systems are not regulated as public drinking water systems and there are no minimum requirements for water quantity or water quality per Idaho Code.

The Idaho Department of Water Resources (IDWR) regulates and permits all well drilling and water rights, and permits water rights to draw from surface water in Idaho. Private water systems may have domestic water rights through IDWR. Some may have individual ownership, or shared ownership through homeowner agreements.

### **Section 2.2 – Public Water Suppliers (regulated)**

There are several public water suppliers throughout Bonner County. The Idaho Department of Environmental Quality (DEQ) regulates public drinking water systems (PWS) under the Idaho Rules for Public Drinking Water Systems (IDAPA 58.01.08) and all PWS are required to meet Idaho Rules for construction, maintenance, and operation. These rules dictate sanitary standards for water quality and water quantity. DEQ approves capacity to serve and provides authorization to serve from PWSs.

*A PWS is defined under Idaho code as: A system for the provision to the public of water for human consumption through pipes or, after August 5, 1998, other constructed conveyances, if such system has at least fifteen (15) service connections, regardless of the number of water sources or configuration of the distribution system, or regularly serves an average of at least twenty-five (25) individuals daily at least sixty (60) days out of the year. Such term includes: any collection, treatment, storage, and distribution facilities under the control of the operator of such system and used primarily in connection with such system; and any collection or pretreatment storage facilities not under such control which are used primarily in connection with such system. Such term does not include any "special irrigation district."*

# Chapter 3 – Power Plants, Utility Transmission Corridors, and Utility Companies

## Section 3.1 – Hydroelectric Dams

The Cabinet Gorge Dam, owned by Avista Utilities, has two substations. One is operated by the Bonneville Power Association, the other is operated by Avista Utilities. The dam, built in 1952, is a concrete arch structure and has 42,780 acre feet of storage. The Cabinet Gorge Dam is located on the Clark Fork River, east of Clark Fork, Idaho.

The Albeni Falls Dam is operated by the U.S. Army Corps of Engineers. The dam is a concrete gravity structure that was built in the mid-1950s. The dam can store 1.15 million acre feet of water. The Albeni Falls Dam is located on the Pend Oreille River at Albeni Falls near Oldtown, Idaho.

## Section 3.2 - Utility Transmission Corridors

### BONNEVILLE POWER - SPOKANE REGION TRANSMISSION LINES

**Location:** There are two electrical transmission lines that compose the Spokane Regional Transmission corridor. The first extends from Albeni Falls Dam through Sandpoint, then north into Bonners Ferry. The second extends from Cabinet Gorge Dam running south along the eastern edge of Lake Pend Oreille, exiting Bonner County near Bayview.

**Service Area Boundary:** These lines are part of a system that serves eastern Washington, North Idaho, and portions of western Montana.

### TRANSCANADA PIPELINES LIMITED / TC ENERGY CORPORATION

**Location:** Two high-pressure natural gas lines run from the Northeast portion of the County, near the Samuels area, to the Southern portion of the County, North of Athol.

**Service Area Boundary:** TC Energy provides wholesale natural gas to Avista Utilities which distributes natural gas via retail service lines.

## Section 3.3 – Power Utility Companies

### INLAND POWER COMPANY

**Location:** There is no transmission in Bonner County.

**Service Area Boundary:** Inland Power provides distribution service in the Oldtown and Blanchard in Bonner County, see [Figure 42](#) for a coverage map.

Note: Inland Power & Light does use population growth projection, satellite imagery, and load calculation help determine system improvement work. These projections are used to assist in making decision regarding building new substations locations or increasing the capabilities on existing substations, increasing the size of conductor both overhead and underground, adding additional phases to the poles and placing more regulators to keep the required voltages needed.

## **NORTHERN LIGHTS**

**Location:** Northern Lights uses Rural Electric Cooperative power lines, but has no specific transmission corridor.

**Service Area Boundary:** Northern Lights serves portions of Bonner, Boundary, Kootenai, Pend Oreille, Lincoln, and Sanders counties. In Bonner County, the service boundaries are generally south of Sagle to Vay, Priest Lake, Upper Pack River, Samuels, Selle, and Schweitzer. Substations are located in Athol, Blue Lake, Cabinet Gorge, Coolin, Dufort, Laclede, Lamb Creek, Ponderay, Priest River, Samuels, Sandpoint, Selle, and Schweitzer. See [Figured 43](#) for a coverage map.

Note: In recent years NLI has experienced a surge in new service applications across all service areas, Bonner County in particular. The demand for new services has primarily been for single-phase residential electric services. A smaller portion of newer services have been for three-phase power for commercial, recreational, industrial, and agricultural uses. In most cases, NLI has been willing and able to accommodate these line extensions to provide service to its members.

## **AVISTA UTILITIES**

**Location:** No specific corridor is present in Bonner County.

**Service Area Boundary:** Avista Utilities serves the following community areas: Blanchard, Clark Fork, Dover, Hope, East Hope, Oldtown, Sagle, Priest River, Ponderay, Kootenai, and Sandpoint.

# **Chapter 4 – Fire Station and Fire Fighting Equipment**

## **Section 4.1 – Fire Districts**

There are 12 fire districts in Bonner County, listed below. The majority of the districts operate on a volunteer basis. Not all areas throughout Bonner County are located within a fire district. See [Figures 25 through 37](#) for a map of each fire tax district.

## **Section 4.2 - Public Lands Fire Protection**

Fire protection of public lands is conducted by United States Forestry Service and the Idaho Department of Lands. Federal and State fire district information is listed below. See [Figure 38](#) for a map of the Idaho Department of Lands and US Forest Service Fire Protection Districts.

Forest Service coverage districts include:

1. Priest Lake Ranger District
2. USFS Bonners Ferry
3. USFS Sandpoint

**Idaho Department of Lands coverage districts include:**

1. IDL Priest Lake Forest Protective District
2. IDL Pend Oreille Forest Protective

## **Section 4.3 – Lands Located Outside of Fire Districts**

Not all areas within Bonner County are located within an incorporated fire district, the incorporated fire districts are noted in section 4.1. Areas outside of fire districts should be utilized for lower density residential uses unless evidence is provided of a subscription or availability of fire services.

## **Chapter 5 – Drainage**

### **Section 5.1 – Bonner County Stormwater Ordinance**

Bonner County Revised Code contains a stormwater ordinance in Title 12, Chapter 7. The purpose of the ordinance is to protect property, surface water and groundwater against significant adverse effects from excavation, filling, clearing, unstable earthworks, soil erosion, sedimentation and stormwater runoff, and to provide maximum safety in the development and design of building sites, roads and other service amenities.

There are no drainage districts located in unincorporated Bonner County.

# Chapter 6 – Health and Welfare Facilities

## Section 6.1 - Overview of Health Facilities

### **BONNER GENERAL HOSPITAL**

Bonner General Hospital is an acute care hospital located in the city of Sandpoint.

### **PANHANDLE HEALTH DISTRICT**

The Panhandle Health District provides over 40 different public health programs to families, individuals and organizations in northern Idaho.

### **EMERGENCY MANAGEMENT SERVICES (EMS)**

#### **Bonner County EMS**

See [Figure 39](#) for a map of all EMS Coverage Zones. Bonner County EMS subcontracts with a variety of emergency service providers, to include:

1. Clark Fork Valley Ambulance Service Inc.
2. Spirit Lake Fire Protection District
3. Schweitzer Fire Protection District
4. Priest Lake EMT's Inc.

All agencies have contracts with Bonner County EMS (BCEMS) and they are updated annually. As of September 2023, there are no plans for any of these providers to expand areas of coverage. The only future expansion plans involve placing a station for BCEMS in the Blanchard area.

# Chapter 7 – Libraries

## Section 7.1 - Bonner Community Libraries

### **Section 8.3 – Future Solid Waste Improvement Plans**

2. Dickensheet Site - Add water source, pavement and an open building for loader storage
3. Idaho Hill Site - Add water source and pavement
4. Dufort Site - Add additional Z walls for additional roll off containers

## **Chapter 9 – Public Schools**

Bonner County consists of two school districts, Lake Pend Oreille and West Bonner County. ## **Chapter 10 – Public Safety Facilities and Related Services**

The Bonner County Emergency Operations Plan (EOP) implements the Idaho Disaster Preparedness Act, as amended in Chapter 10, Title 46, Idaho Code. The current EOP, adopted via Resolution 2021-55 and dated June 29, 2021, is the official plan for Bonner County intergovernmental emergency operations. The extensive plan is applicable to all elements of county and city governments, other cooperating separate government entities, and commercial, industrial, and private/non-profit organizations engaged in or support of emergency operations. Periodic exercises are scheduled to provide familiarity with emergency conditions. The document was adopted by Bonner County, Bonner County Sheriff's Office, Bonner General Health, and the cities of Clark Fork, Dover, Kootenai, and Priest River. (Bonner County Emergency Operations Plan.)








Figure 3. Coolin Sewer District Map












Figure 8. Ellisport Bay Sewer District Map






Figure 11. Syringa Heights Water District Map




Figure 13. Overview Map of All Water & Sewer Districts




Figure 14. Diamond Park Paradise Point Water & Sewer District Map






Figure 15. Granite-Reeder Water & Sewer District Map








Figure 18. West Bonner Water & Sewer District Map












Figure 23. Garfield Bay Water & Sewer District Map












Figure 29. Coolin Cavanaugh Bay Fire District








Figure 32. Schweitzer Fire District

















Figure 39. EMS Zones







Figure 43. Northern Lights Coverage Area
