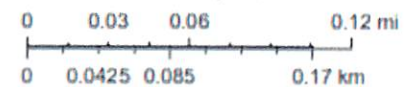

Site Plan Details: Current Use Areas

3- 140x45 Parking Lot

Flat open area, graveled over and clearly marked off.
Directly attached to a pre-existing asphalt driveway.
No environmental change.
No Electricity or any service associated with this area.

9- 1300 ft. Road

Road is directly attached to a pre-existing asphalt driveway, leading to playing areas.
Partially down hill slope following terrain.
Road was initially a logging road from the 80's, used again in 2020 for logging.
Wasn't changed or altered, other than adding a gravel base to reduce mud and washout.
No one is permitted to drive this road, except Owners of property or business.

Playing fields

2- 75ftx75ft Kids (7-11 ages) playing field

6x6 posts suspend 12ft paintball rated nets to avoid paintballs leaving designated areas.

This area consists of Air Inflated Bunkers, attached by gardening stakes and paracord.

Original area was a sandy and topsoil area, no change was made for this area.

1- 300ftx150ft (12+ ages) playing field

6x6 posts suspend 12ft paintball rated nets to avoid paintballs leaving designated areas.

This area consists of barrels, pallets, decommissioned vehicles, man-made dirt berms (only 4ft tall) and natural tree cover.

Only changes made for this area were underbrush and stump clearing, grading to remove holes and trip hazards, and removal of 1 large dangerous leaning tree & a few small saplings where the required nets were implemented.

No protruding objects or climbable objects.

No electricity or other service is connected or implemented anywhere near these areas.

8- Restroom area

Consisting of 2 port-johns and 1 wash station (non potable water)

1 restroom for Males and another for Females.

Set apart from Playing Areas, but still in a public setting.

Proposed areas

Areas:

- 4- May be a large untouched area of thick woodland**
- 5- May be a large area, mixed with flat and slightly sloped areas. Would be divided into smaller playing fields.**
- 6- Will eventually turn into an open area, designed for picnic/rest area for family and friends who may spectate instead of participating. Possibly activities for smaller kids that would be family friendly, including archery tag.**
- 7- Will be a "Shooting Gallery" for paintballs to be fired in a safe environment to play for prizes. Also allows younger kids to use the larger paintball guns safely.**
