

NOTICE IS HEREBY GIVEN that the Bonner County Commissioners will hold a public hearing at **1:30 pm** on **Wednesday**, **February 12**, **2025** in the Bonner County Administration Building, 1500 Highway 2, Sandpoint, Idaho, by Zoom teleconference, and YouTube Livestream to consider the following request:

File VS0004-24 - Vacation - Title 50 - Plat Vacation

The applicants are requesting a Title 50 Plat Vacation of "Irontop Ridge", recorded in Bonner County Records as instrument number 1035134, Book of Plats 21, Page 96 on July 01, 2024. The purpose of this vacation is to extinguish the current plat, and create four (4) 5-acre lots, instead of two (2) -10 acre lots as was recorded by the plat. The 9.71 & 9.77-acre lots are zoned Rural 5. The project site is located off Tahoe Drive in Section 8, Township 56 North, Range 2 East, Boise-Meridian, Idaho.

Staff reports are available online or may be viewed at the planning department approximately a week before the scheduled hearing.

Written statements must be submitted to the planning department record no later than seven (7) days prior to the public hearing. Written statements not exceeding one standard letter sized, single spaced page may be submitted at the public hearing. Statements can be sent to the Bonner County Planning Department at 1500 Highway 2, Suite 208, Sandpoint, Idaho 83864; faxed to 866-537-4935 or e-mailed to planning@bonnercountyid.gov. The referenced start time stated above reflects the beginning of the hearing. Specific file start time and hearing duration vary.

During the hearing for this application, the public will be given an opportunity to provide testimony and/or evidence regarding how the proposal does or does not comply with the applicable approval criteria of the Bonner County Revised Code. At the close of the public hearing, the governing body will make a decision on the application that may include, but is not limited to, approval, denial, remand, or continuance of the public hearing.
