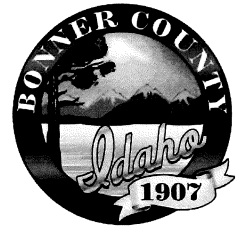

NOTICE IS HEREBY GIVEN that the Bonner County Zoning Commission will hold a public hearing at **5:30 pm on Thursday, July 18, 2024** in the Bonner County Administration Building, 1500 Highway 2, Sandpoint, Idaho, by Zoom teleconference, and YouTube Livestream to consider the following request:

File ZC0004-24 - Zone Change - Recreation/Rural 5 to Recreation. The applicants are requesting a zone change from Recreation/Rural 5 to Recreation. The 0.48-acre property is split zoned Recreation and Rural 5. The project site is located off Mariner Way and Highway 200 in Section 1, Township 56 North, Range 1 East, Boise-Meridian.

Staff reports are available online or may be viewed at the planning department approximately a week before the scheduled hearing.

Statements can be sent to the Bonner County Planning Department at 1500 Highway 2, Suite 208, Sandpoint, Idaho 83864; faxed to 866-537-4935 or e-mailed to planning@bonnercountyid.gov. The referenced start time stated above reflects the beginning of the hearing. Specific file start time and hearing duration vary.

During the hearing for this application, the public will be given an opportunity to provide testimony and/or evidence regarding how the proposal does or does not comply with the applicable approval criteria of the Bonner County Revised Code. At the close of the public hearing, the governing board will make a decision on the application that may include, but is not limited to, approval, denial, remand, or continuance of the public hearing.
