**NOTICE IS HEREBY GIVEN** that the Bonner County Commissioners will hold a public hearing at **1:30 pm** on **Wednesday, August 28, 2024** in the Bonner County Administration Building, 1500 Highway 2, Sandpoint, Idaho, by Zoom teleconference, and YouTube Livestream to consider the following request:

**File ZC0004-24 - Zone Change - Recreation/Rural 5 to Recreation.** The applicants are requesting a zone change from Recreation/Rural 5 to Recreation. The 0.48-acre property is zoned Commercial. The project site is located off Mariner Way and Highway 200 in Section 1, Township 56 North, Range 1 East, Boise-Meridian. The Zoning Commission at the July 18, 2024, public hearing, recommended approval of this file to the Bonner County Commissioners.
