Dear Commissioners:

The West Bonner County School District has concerns about the CUP005-25 for Curtis Creek Mining/Gravel. Mainly the extra traffic/trucks per week on Curtis Creek and Spirit Lake Cutoff Rd intersection during the school bus morning and afternoon routes. We feel that there could be problems with the trucks not being aware of the areas where traffic can be seen before the intersection to make it safer to pull out and less dangerous for others on the road. The addition of school bus stop ahead signs might need to be placed before the intersection of Hoodoo Mtn. Rd and Curtis Creek Rd, on each of the side roads. These signs would also be helpful near the multiple hard corners of Spirit Lake Cut Off going both directions. There are frequent stops near the corners and that would help give the drivers notice of stops ahead. We feel that this would help make it more safe for our children riding the buses.
