My name is Dakota Morgan. I own and operate 7B paintball.

I'll be sending a few attachments with some details on our recreational facility.

First, I just want you to know there are no buildings or structures.

Secondly, there's only a gas powered HPA Compressor, stored and operated in enclosed trailers. This compressor makes minimal noise and exhaust.

Third, there is a smoking area roughly 15x15 gravel/rock with a butt-bucket.

We have a few fire extinguishers.
