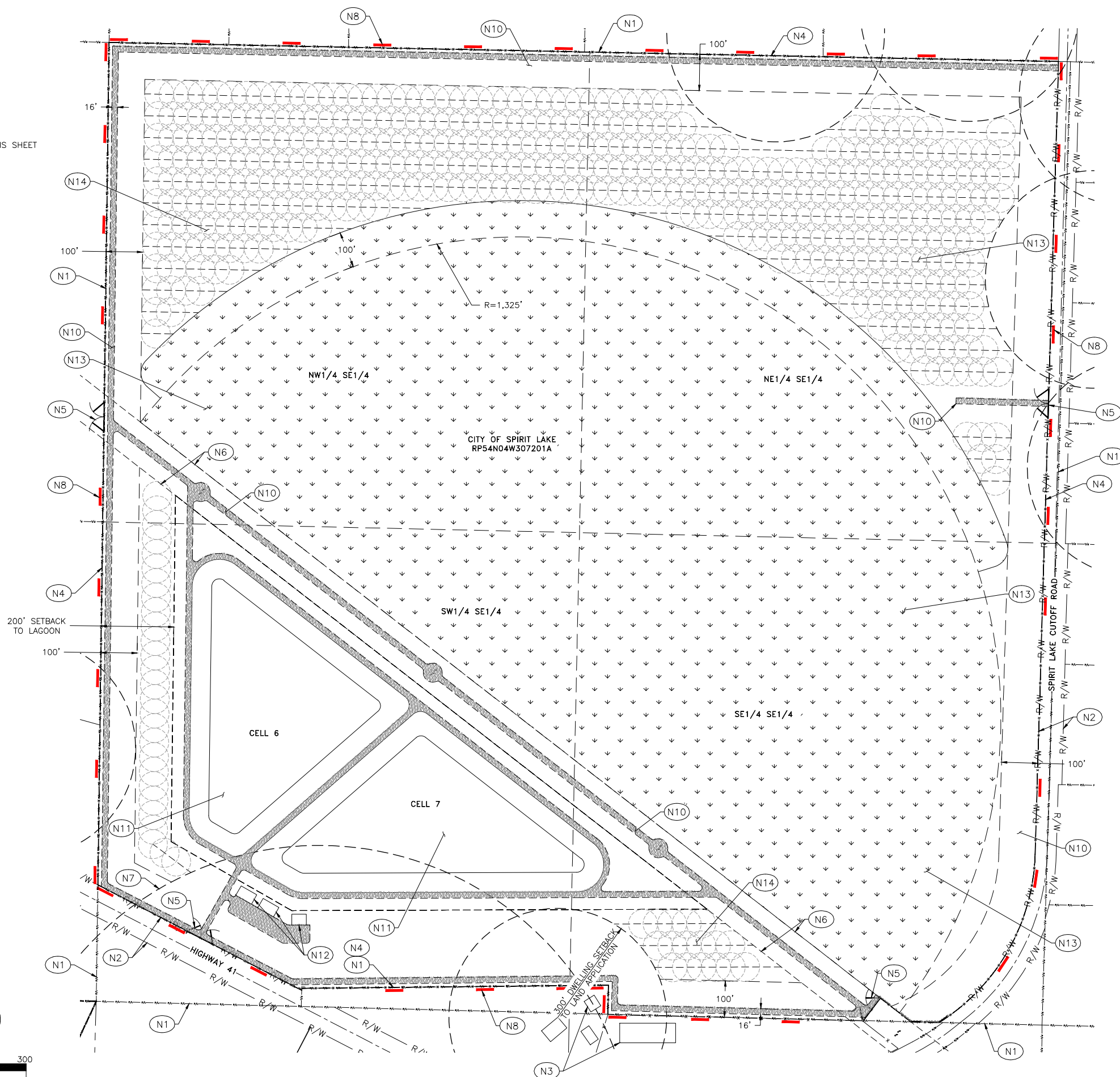

WARNING SIGN FOR LAND APPLICATION AREA



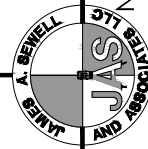
