File V0017-25 - Variance - Property Line Setback

The applicant is requesting a 3-inch property line setback where 5 feet is required for an existing deck. The 0.500-acres property is zoned Recreation. The project site is located off Outlet Bay Road in Section 06, Township 59 North, Range 04 West, Boise-Meridian.

The referenced start time stated above reflects the beginning of the hearing. Specific file start time and hearing duration vary.

During the hearing for this application, the public will be given an opportunity to provide testimony and/or evidence regarding how the proposal does or does not comply with the applicable approval criteria of the Bonner County Revised Code. At the close of the public hearing, the governing body will make a decision on the application that may include, but is not limited to, approval, denial, remand, or continuance of the public hearing.
