Dear Tim,

The Bonner County Commissioners, at the April 2, 2026 hearing, denied the referenced application.

Commissioner Williams moved to affirm the Bonner County Zoning Commission's decision and deny this project V0031-25 based upon the following conclusions:

Conclusion 1

Conditions **do not** apply to the property that **do not** apply generally to other properties in the same zone or vicinity, which conditions are a result of lot size, shape, topography, or other circumstances over which the applicant has no control.

Conclusion 2

Special conditions and circumstances **do not** result from the actions of the applicant.

Conclusion 3

The granting of the variance **is** in conflict with the public interest in that it **will** be detrimental to the public health, safety, or welfare, or materially injurious to properties or improvements in the vicinity of the subject parcel or lot. (Ord. 559, 1-4-2017)

This decision is based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at the hearing. Commissioner Williams further moved to adopt the reasoned statement as discussed in deliberation at this hearing and the analysis as set forth in the Staff Report (or as amended during this hearing) and direct planning staff to draft the reasoned statement to reflect this motion as set forth in Idaho Code section 67-6535, have the Chair sign, and

transmit to all interested parties. This action does not result in a taking of private property. The action that could be taken, if any, to obtain the variance is to:

1. File a new application with the Planning Department and meet the standards required by Bonner County Revised Code; or
2. Pursue such remedies as may be applicable at Title 67, Chapter 65, Idaho Code.


Voted upon and the Chair declared the Motion passed, unanimously.

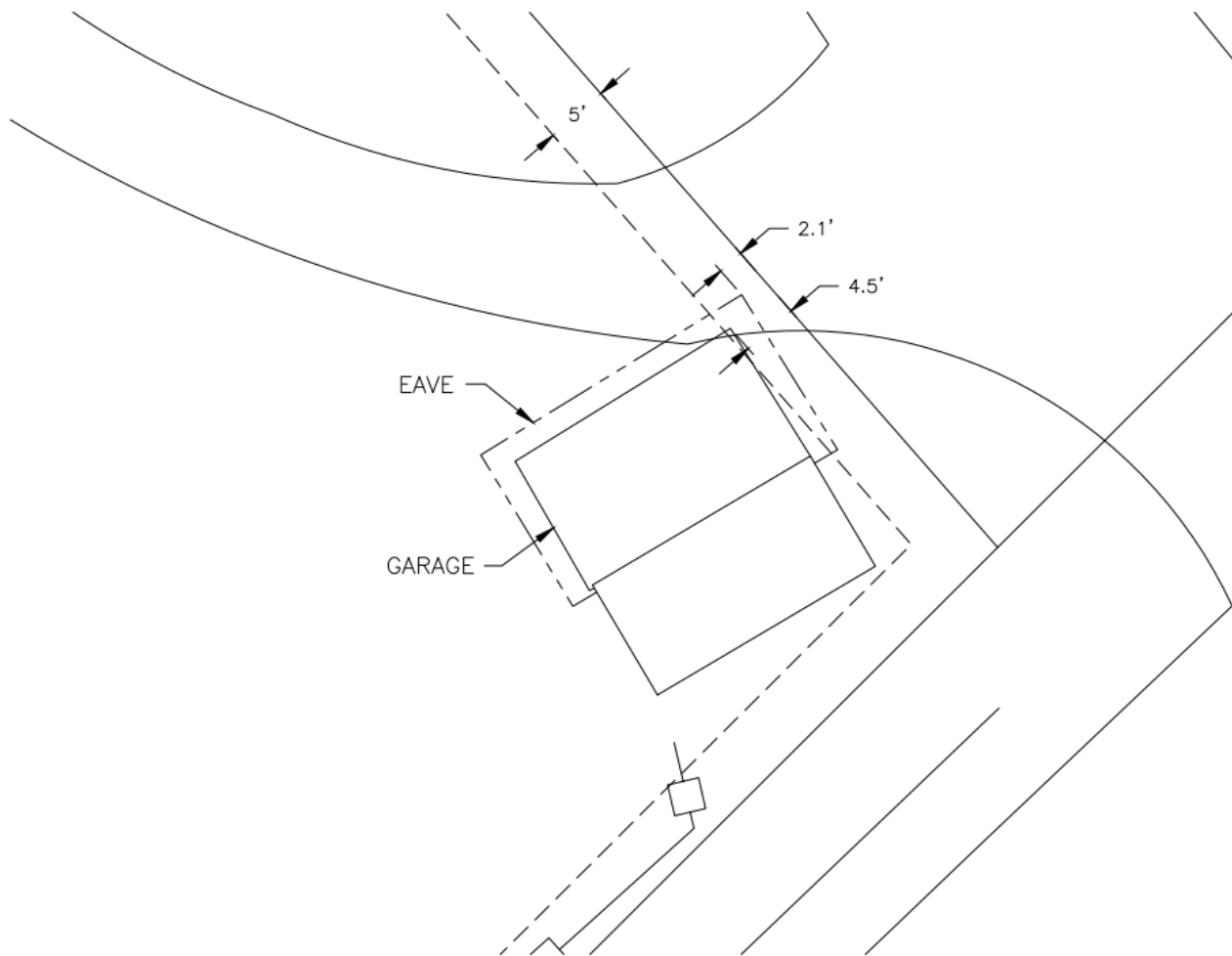

Project summary:

The applicant is requesting a 2.1' street setback where 25 feet is required for the expansion of a legal nonconforming accessory building. The 0.630-acre property is zoned Recreation (Rec). The project site is located on the corner of Creekside Drive and Kalispell Bay Road in Section 12, Township 60 North, Range 5 West, Boise-Meridian.

F. BCRC 12-232, General Provisions

Staff: In accordance with BCRC 12-232, the applicant is seeking a 91.6% variance to street setbacks.

G. BCRC 12-233, Application, contents

Staff: In accordance with BCRC 12-233, the applicant submitted all the required documents and the application was deemed complete on October 6, 2025.

H. BCRC 12-234, Variances, standards for review of applications

BCRC 12-234 specifies that "The staff, Zoning Commission, hearing examiner and/or Board shall review the particular facts and circumstances of each proposal submitted. To grant a variance, the hearing examiner or the Governing Body must find adequate evidence showing that:"

- (a) **Conditions apply to the property that do not apply generally to other properties in the same zone or vicinity, which conditions are a result of lot size, shape, topography, or other circumstances over which the applicant has no control.**

Applicant: "The existing garage was built in the 1960s before the current landowner purchased the property. Its existing location was within the front and sideyard setbacks of Kalispell Bay Road and Creekside Drive. An addition was added to the north side of the garage by the current landowner who was unaware of the encroachment."

Staff: While the subject property does contain mapped slopes, per GIS LiDAR data, they are very minimal and appear to be associated with roadside ditches. The subject property does not contain any mapped wetlands or bodies of water and is within SFHA Zone D, which does not require floodplain development permitting. The lot is approximately 0.63-acres in size and rectangular in shape. Many lots in the vicinity have one street setback on their property, whereas the subject property has frontage on two streets, Creekside Drive and Kalispell Bay Road, requiring setbacks to two streets.

There is no evidence that the landowner has changed the lots size, shape or topography of the lot since obtaining it.

- (b) **Special conditions and circumstances do not result from the actions of the applicant.**

Applicant: "Similar setback reductions have been allowed in the past within the same community."

Staff: Per Warranty Deed, Instrument #933885, the current owner acquired the subject property in January of 2019. Based on Assessor data for the property, the original structure was built in 1960 which would make it a legal nonconforming structure per BCRC 12-344; however, per BCRC 12-344 (A) No such nonconforming structure may be enlarged or altered in any way which increases its nonconformity. To alter or increase the size of the nonconforming structure, an approved variance is required.

Via GIS Imagery from 2023-2024, it was determined that an addition to the legal nonconforming structure was added. Subsequently a Zoning Violation, file number ZV0005-24, was initiated on October 8, 2024.

- (c) **The granting of the variance is not in conflict with the public interest in that it will not be detrimental to the public health, safety, or welfare, or materially injurious to properties or improvements in the vicinity of the subject parcel or lot.**

Applicant: "Allowing the existing structure to remain with a reduced street back would not affect the existing road network and would not affect the building area of neighboring properties."

Staff: A comment submitted by Northern Lights, Inc. states the proposed changes to the structure will not affect their right of way or operations. Bonner County Road & Bridge submitted a comment in opposition to the proposed variance as a reduced setback can create issues when maintaining the road and utilities. (Full Road & Bridge comment can be found in the attached Appendix B.)

No other comments from the public or any public agency or taxing district were received that stated that the proposed project would be detrimental to the public health, safety, or welfare or be materially injurious to the surrounding properties or improvements within the vicinity of this project.

I. BCRC 12-412, Density and Dimensional Standards; Suburban, Commercial, Industrial, Rural Service Center, Recreation and Alpine Village Zones

Per BCRC 12-412 Table 4-2, the street setback in the Recreation zone is 25'. This request is proposing a deviation from this standard to allow for a 2.1' setback. Per the submitted site plan, the original structure was setback approximately 5'.

J. BCRC 12-262: Appeals from Final Decision of Commission/Hearing Examiner

A. Presentation Of Appeal: Any "affected person", as defined by Idaho Code title 67, chapter 65, may appeal to the Board any final decision by the Zoning Commission/hearing examiner.

Staff: The appeal was filed by the applicant/project representative of this project.

B. Filing Time Limit; Fee: Any affected person may file an appeal of the final decision of the Zoning Commission/hearing examiner with the Planning Director within twenty eight (28) days after the final written decision of the Zoning Commission/hearing examiner has been issued. The appellant shall pay the fee required by this title upon filing the appeal. An appeal shall not be considered to be filed until such fee has been paid. Failure to file the appeal within the time limits shall cause automatic dismissal of the appeal.

Staff: The written decision for this file was sent to the applicant on January 28, 2026. The appeal letter and fees were received on February 25, 2026. The appeal was submitted, and fees paid, within the 28-day appeal period.

C. Notice Of Appeal Contents: The notice of appeal shall be detailed in writing and shall provide the grounds for the appeal. The grounds for appeal shall be that the decision of the commission or hearing examiner was at a minimum one of the following:

1. In violation of constitutional or statutory provisions;
2. In excess of the statutory authority of the commission or hearing examiner;
3. Made upon unlawful procedure;
4. Arbitrary, capricious or an abuse of discretion; or
5. Not supported by substantial evidence on the record as a whole.

Staff: Per the appeal letter, this appeal is being made based on an inadequate presentation of the project issues at the January 8th hearing. Per the project rep, "Clear and concise mapping and presentation of the issue was not made at the initial hearing".

D. Procedures For Consideration Of Appeal:

1. Within sixty (60) days of the receipt of the appeal, the Board shall conduct a public hearing. The hearing shall be conducted in the same manner using the same standards, as if the Board had original jurisdiction to hear the application.

Staff: Based on the receipt of the appeal, February 25, 2026, the Board shall conduct a public hearing for this appeal no later than April 26, 2026. This file is currently scheduled to be heard by the BOCC on April 2, 2026.

2. Upon consideration, the Board may affirm, reverse, or modify the decision of the Zoning Commission/hearing examiner, after compliance with applicable procedural standards.

3. The decision of the Board shall be final, and any further recourse shall be as provided by law.

K. BCRC 12-7.2, et seq., Grading/erosion/stormwater management

Stormwater Management concerns will be addressed during the Building Location Permit phase in accordance with BCRC 12-720. No further review is required for this project.

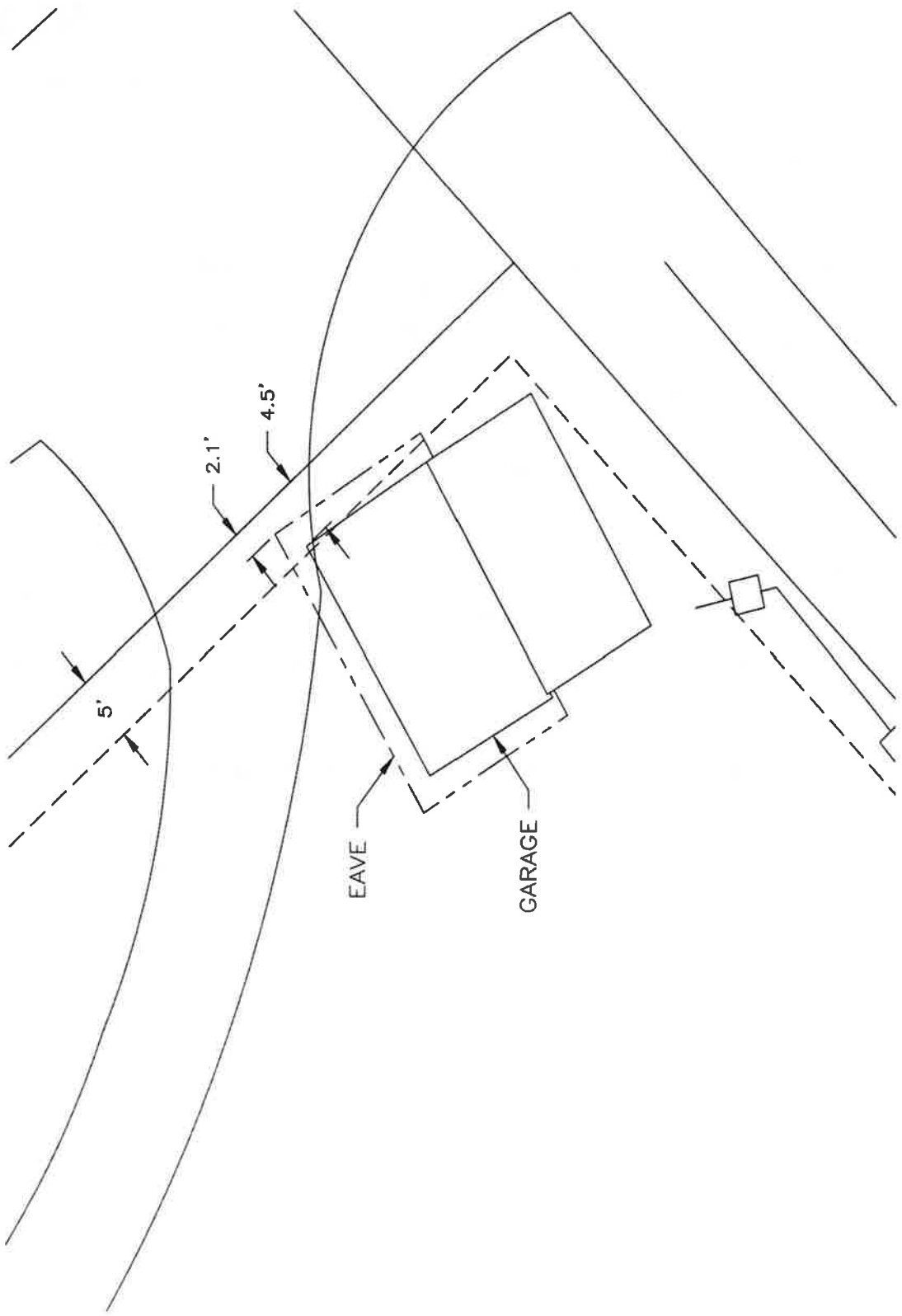



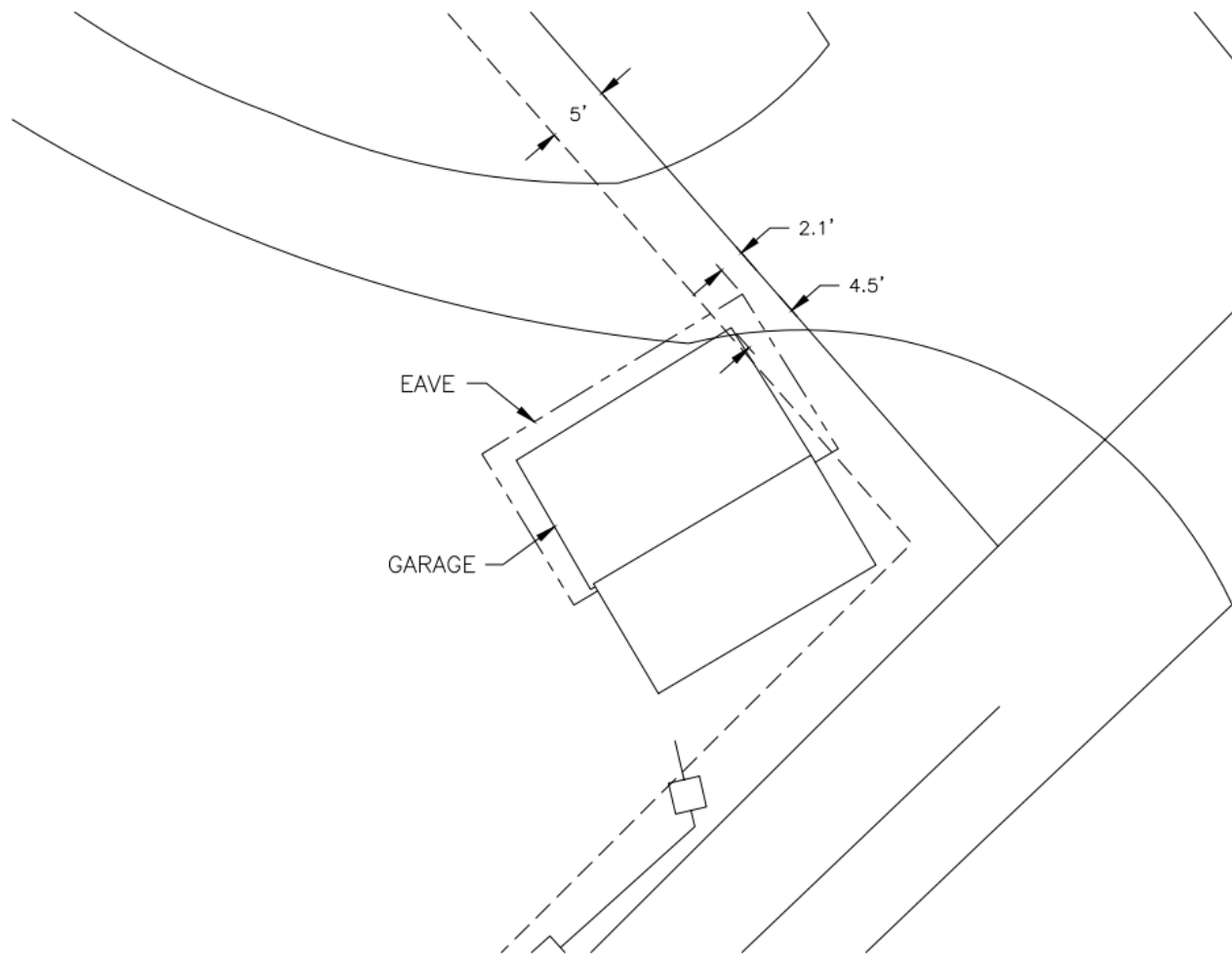

Applicant: "The existing garage was built in the 1960s before the current landowner purchased the property. Its existing location was within the front and sideyard setbacks of Kalispell Bay Road and Creekside Drive. An addition was added to the north side of the garage by the current landowner who was unaware of the encroachment."

Staff: While the subject property does contain mapped slopes, per GIS LiDAR data, they are very minimal and appear to be associated with roadside ditches. The subject property does not contain any mapped wetlands or bodies of water and is within SFHA Zone D, which does not require floodplain development permitting. The lot is approximately 0.63-acres in size and rectangular in shape. Many lots in the vicinity have one street setback on their property, whereas the subject property has frontage on two streets, Creekside Drive and Kalispell Bay Road.

There is no evidence that the landowner has changed the lots size, shape or topography of the lot since obtaining it.

- (b) Special conditions and circumstances do not result from the actions of the applicant.**

Applicant: "Similar setback reductions have been allowed in the past within the same community."

Staff: Per Warranty Deed, Instrument #933885, the current owner acquired the subject property in January of 2019. Based on Assessor data for the property, the original structure was built in 1960 which would make it a legal nonconforming structure per BCRC 12-344; however, per BCRC 12-344 (A) No such nonconforming structure may be enlarged or altered in any way which increases its nonconformity.

Via GIS Imagery from 2023-2024, it was determined that an addition to the legal nonconforming structure was added. Subsequently a Zoning Violation, file number ZV0005-24, was initiated on October 8, 2024.

- (c) The granting of the variance is not in conflict with the public interest in that it will not be detrimental to the public health, safety, or welfare, or materially injurious to properties or improvements in the vicinity of the subject parcel or lot.**

Applicant: "Allowing the existing structure to remain with a reduced street back would not affect the existing road network and would not affect the building area of neighboring properties."

Staff: A comment submitted by Northern Lights, Inc. states the proposed changes to the structure will not affect their right of way or operations. Bonner County Road & Bridge submitted a comment in opposition to the proposed variance as a reduced setback can create issues when maintaining the road and utilities. (Full Road & Bridge comment can be found in the attached Appendix B.)

No other comments from the public or any public agency or taxing district were received that stated that the proposed project would be detrimental to the public health, safety, or welfare or be materially injurious to the surrounding properties or improvements within the vicinity of this project.

I. BCRC 12-412, Density and Dimensional Standards; Suburban, Commercial, Industrial, Rural Service Center, Recreation and Alpine Village Zones

Per BCRC 12-412 Table 4-2, the street setback in the Recreation zone is 25'. This request is proposing a deviation from this standard to allow for a 2.1' setback. Per the submitted site plan, the original structure was setback approximately 5'.

BCRC 12-7.2, et seq., Grading/erosion/stormwater management

Stormwater Management concerns will be addressed during the Building Location Permit phase in accordance with BCRC 12-720. No further review is required for this project.



The Bonner County Road & Bridge Department is opposed to the requested 2ft street setback variance from the edge of Creekside Drive right of way. The road is a County maintained road, and structures this close to the road create issues with our ability to maintain the road, plow snow, trim brush, etc. effectively without taking special care not to damage buildings. For example, snow, ice, and rocks can fly 30ft off of the blades of passing snow plows. When doing brushing projects, pulverizing stumps and brush with the attachment on our excavator can throw woody debris quite a distance, all of which can damage siding, windows, etc.

Utilities need to be installed outside of the road prism and as near as practical to the edge of the public right of way according to the Bonner County Road Standards Manual Section 2.5E. This puts power lines and other utilities too close to the edge of the building or forces the utilities to be installed closer to the road to maintain a reasonable separation from the structures. Utilities being closer to the road impacts our ability to upgrade and improve the road in the future, and in many cases forces the utilities into the area reserved for roadside ditches and drainage, further impacting our ability to create and maintain suitably deep ditches. According to the electric companies, they need a minimum of 10ft separation from structures, and this proposed location would make the outer 8ft of the public ROW unsuitable for utility installations if/when the need arises in the future if this 2ft setback were to be permitted.

While the original structure was not the fault of the applicant, expanding the structure and worsening an already problematic setback situation is untenable to our department, and has impacts into the far future.

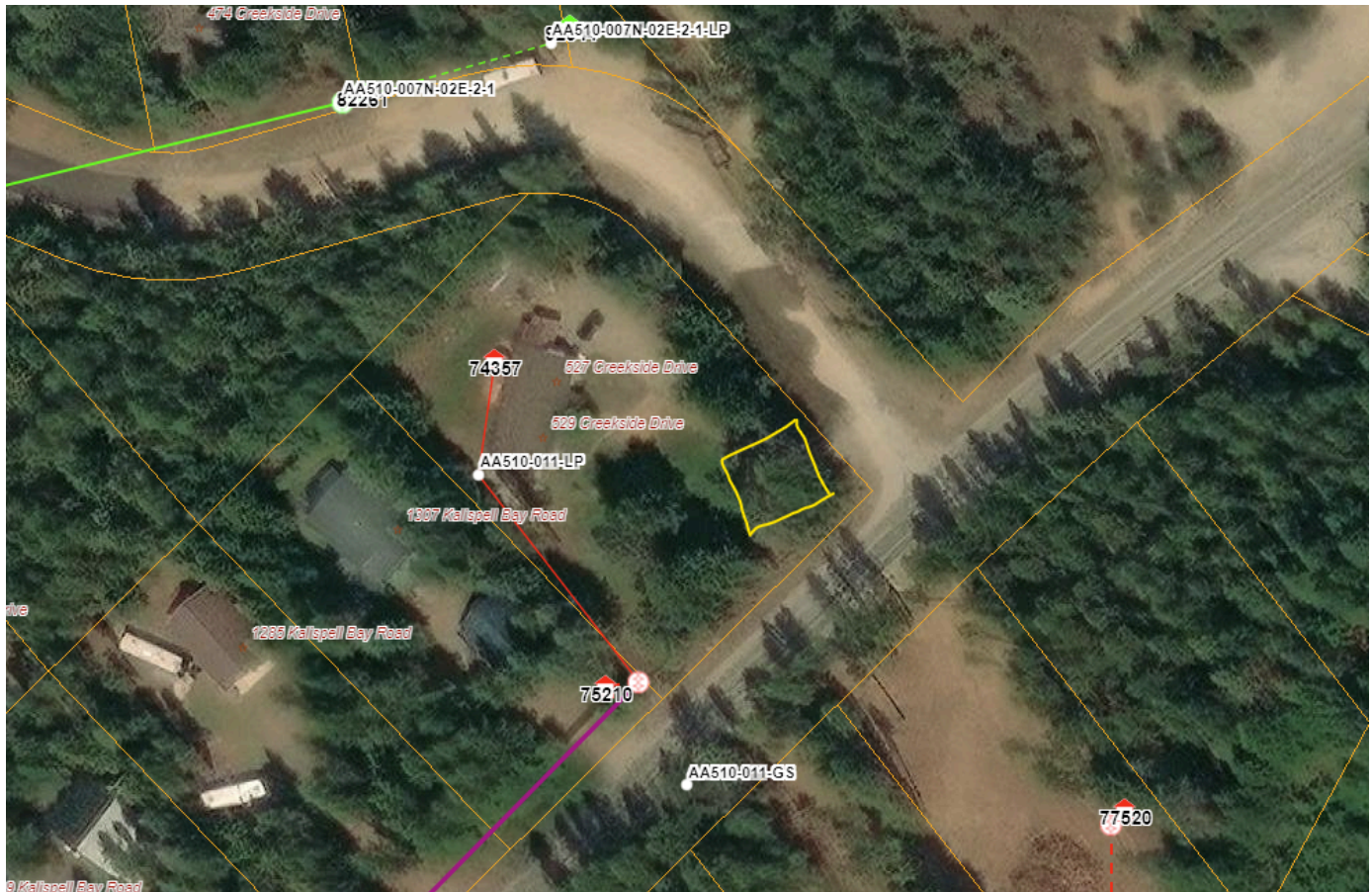

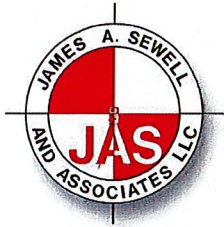

This letter serves as Tim Ventress's appeal of the decision by the Bonner County Planning and Zoning Commission issued on January 28, 2026, that was a result of the hearing on January 8, 2026. A copy of the decision is attached hereto as Exhibit A. This appeal is being made based on an inadequate presentation of the project issues at the January 8th hearing.

Appellant:

The appellant is Tim Ventress who owns the property identified as Bonner County Parcel No. RP003980010070A.

Statement of Facts:

1. The original legal nonconforming structure was constructed in 1960 before the appellant purchased the property.
2. The appellant modified the structure without a building location permit and resulting in a more nonconforming structure.
3. The site was surveyed by James A. Sewell & Associates, LLC on December 2021 and defined the property line locations. A copy has been attached.

4. The original structure resides approximately 5 feet away from the property boundary as measured from the existing building corner and approximately 2 feet from the newly constructed eave to the property boundary. See attached Exhibit.
5. Following communication with the County, the Building Location Permit process will be submitted to Bonner County Planning prior to the appointed hearing date.

Statement of Errors:


1. Clear and concise mapping and presentation of the issue was not made at the initial hearing.
2. The appellant acknowledges that the addition made the legal nonconforming structure more nonconforming. But would be able to remove/modify the eave to match the original structures setback on Creekside Drive. Pictures of the addition are attached.
3. The appellant acknowledges that the addition was made without completing the Building Location Permit process, but will have it completed by the appointed hearing date.

Relief Requested:

1. Reverse the decision
2. Determine that the corrections requested were completed and satisfy Code Violation ZV0005-24.
3. Determine there is no material injury to the public.
4. Determine that there is no public health, safety, or welfare concern resulting from the Ventress property.

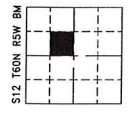
