This application has been reviewed against the standards for a variance in Bonner County Revised Code 12-234 and it has been determined that the request **has met** the criteria based on the findings of fact and conclusion of law. The references application is hereby administratively **approved** per the review below.

Site Plan



Project summary:

The applicant is requesting a 64' shoreline setback where 75' is required for the construction of a residential structure. The property is zoned Agricultural/Forestry 20 (A/f 20). The project site is located off USFS 332 in Section 32/33, Township 53 North, Range 1 West, Boise-Meridian.

BCRC 12-232, General Provisions

The applicant is requesting a variance to the shoreline setback from Prospect Creek for a Single-Family Dwelling. This request is in accordance with this provision.

BCRC 12-233, Application, contents

In accordance with BCRC 12-233, the applicant submitted all the required documents, and the application was deemed complete on May 14, 2025.

BCRC 12-238, Administrative Variances

In accordance with BCRC 12-238, the applicant is seeking a 15% variance to the street, property line, and shoreline setbacks.

BCRC 12-711 Shoreline Setbacks

BCRC 12-711: Shoreline Setbacks lists the setback to a creek at 75' feet.

BCRC 12-234, Variance, standards for review of applications

- (a) **Conditions apply to the property that do not apply generally to other properties in the same zone or vicinity, which conditions are a result of lot size, shape, topography, or other circumstances over which the applicant has no control.**

Applicant: "All the land is steep. Plan to plant clover. Very little places to build."

Staff: According to GIS LiDAR data, the subject property is primarily made up of slopes exceeding 30%. The excessive slopes can make development on the subject property challenging. Additionally, Prospect Creek bisects the property with approximately 4.5-acres North of the creek and 12.5-acres South of the creek. Based on GIS imagery, the structure appears to be built on one of the only relatively flat areas of the property.

A riparian buffer of approximately 64' still exists between the structure and Prospect Creek. Per a comment from Idaho Department of Fish and Game, "This should be a sufficient buffer and act as biofiltration."

- (b) **Special conditions and circumstances do not result from the actions of the applicant.**

Applicant: "No, I did not change the size of the parcel."

Staff: The applicant acquired the subject property on January 26, 2018, via Warranty Deed, Instrument No. 917816, recorded on February 8, 2018. Since the time of acquisition, there is no indication that the applicant has altered the parcel's size, shape, or topography. The applicant has no control over the excessive sloping on the property or the location of the creek.

- (c) **The granting of the variance is not in conflict with the public interest in that it will not be detrimental to the public health, safety, or welfare, or materially**

injurious to properties or improvements in the vicinity of the subject parcel or lot.

Applicant: "I own the property and I am surrounded by national forest & all private land."

Staff: Comments were received from Idaho Department of Fish and Game as well as Idaho Department of Environmental Quality regarding the shoreline setbacks and their role in protecting water quality. The comment from IDFG notes that the existing riparian buffer between the structure and Prospect Creek should be a sufficient buffer and act as biofiltration. A comment was received from the U.S. Army Corps of Engineers noting that a 404 permit may be required for any discharge of fill materials to Waters of the United States and/or their adjacent wetlands.

No other agency or public comments were received indicating this project would be in conflict with the public interest.

I. Stormwater plan

Grading/Stormwater Management and Erosion Control plan concerns were addressed during the Building Location Permit process, file #BLP2025-0217.

J. Agency Review

Agencies were notified of this project on June 23, 2025. A full list of the agencies notified can be found in the attached Appendix A. Agency comments can be found in Appendix B.

Public Notice & Comments

At the time this Staff Report was produced, no public comments have been received.

Staff Review Summary:

According to GIS LiDAR data, the subject property is predominantly composed of slopes exceeding 30%, which presents significant challenges for development. Prospect Creek runs through the property, dividing it into two sections: approximately 4.5 acres lie to the north

of the creek, and around 12.5 acres lie to the south. Based on GIS imagery, the existing structure on the property appears to be situated on one of the only relatively flat areas, likely chosen to minimize construction difficulties. A riparian buffer of approximately 64 feet remains between the structure and Prospect Creek. According to a comment from the Idaho Department of Fish and Game (IDFG), this buffer should be adequate and is expected to serve as a natural biofiltration zone, helping to protect water quality.

Since the time of purchase, there is no indication that the applicant has modified the size, shape, or topography of the parcel. Furthermore, the applicant has no control over the property's steep terrain or the location of Prospect Creek.

CONCLUSIONS: Based on the foregoing findings, the following conclusions are adopted. The proposed administrative variance **is** in accord with the purposes of Title 12. This action does not result in a taking of private property. The action that could be taken to obtain the administrative variance is to complete the Conditions of Approval as adopted.

1. This proposal was reviewed for compliance with the criteria and standards set forth at Sections 12-233 and 12-234, Bonner County Revised Code, storm water management criteria and standards set forth in Chapter 7, Title 12, Bonner County Revised Code, and variance criteria and standards set forth at Section 67-6516, Idaho Code.
2. Conditions apply to the property that **do not** apply generally to other properties in the same zone or vicinity, which conditions are a result of lot size, shape, topography, or other circumstances over which the applicant has no control.
3. Special conditions and circumstances **do not** result from the actions of the applicant.
4. The granting of the variance **is not** in conflict with the public interest in that it **will not** be detrimental to the public health, safety, or welfare, or materially injurious to properties or improvements in the vicinity of the subject parcel or lot.

Conditions of Approval:

1. Only the development highlighted on the site plan has been reviewed for variance standards. All other development shown must comply with Bonner County Revised Code.
2. This variance shall not supersede any deed restrictions.
3. Complete the associated Building Location Permit, File #BLP2025-0217.

NOTE: Any determination made by the Planning Director in the administration of the provisions of this title may be appealed to the Board by paying the required fee and notifying the Planning Director in writing of the intent to appeal within ten (10) working days from the date of the determination. Within ten (10) working of receipt of an appeal, the Planning Director shall schedule a meeting with the Board to hear the appeal and shall provide written notice to the appellant of the time and place of the meeting. The Planning Director and appellant shall be provided an opportunity to present the relevant issues to the Board at that meeting. The appellant bears the burden of proof and may be responsible for costs incurred for producing such proof, including engineering or surveying documents

for other evidence. The Board's decision shall be final, and further recourse of the appellant shall be as provided by Idaho Code. If no appeal to the Board is filed, the Planning Director's decision shall be deemed final. (BCRC 12-261)

Following any final decision concerning a site-specific land use request, the applicant has a right to request a regulatory taking analysis pursuant to Section 67-8003, Idaho Code (Idaho Code §67-6535(3)).

Development setbacks from stream banks and lake shorelines are an important tool for protecting water quality. Riparian vegetation provides natural filtration of stormwater runoff and provides numerous other benefits to promote healthy surface water ecology. DEQ recognizes that there are sometimes unique circumstances that may justify reduced setbacks. While an individual variance likely has a relatively small impact on water quality, the cumulative impact of development in close proximity to shorelines and stream banks is a significant threat to water quality. DEQ advises local government planning departments to maintain established setbacks whenever possible. Exceptions should be considered carefully by the local jurisdiction and used only when absolutely necessary to accommodate unique circumstances.
