BCRC 12-232, General Provisions

The applicant is requesting a variance to the 35% maximum impervious surface coverage near water. This request is in accordance with this provision.

BCRC 12-233, Application, contents

In accordance with BCRC 12-233, the applicant submitted all the required documents, and the application was deemed complete on May 20, 2025.

BCRC 12-238, Administrative Variances

In accordance with BCRC 12-238, the applicant is seeking an 8% variance to the maximum impervious surface .

BCRC 12-713, Impervious Surface Standards Near Water

BCRC 12-713: Sets the maximum "impervious surface" within "shore land" areas at 35%.

BCRC 12-7.2, et seq., Grading/erosion/stormwater management

Stormwater management concerns were addressed with the Building Location Permit, File #BLP2025-0638. A stormwater management plan was submitted to and approved by Bonner County Engineering.

BCRC 12-234, Variance, standards for review of applications

- (a) **Conditions apply to the property that do not apply generally to other properties in the same zone or vicinity, which conditions are a result of lot size, shape, topography, or other circumstances over which the applicant has no control.**

Applicant: "The existing lot shape is triangular starting with the pointed end toward the east or access location. This lot was a tax lot and adjoins a platted subdivision to the South. As such, the tax lot boundaries result in a remainder parcel that pinches on its East end and limits access. The proposed garage/adu is located as far to the east of the lot, or away from the lake, as possible. In order to provide access around the garage/adu on the north side, the ADU was positioned one lane width off of the north property line. This provides access but requires construction of additional impervious area within 200ft of the waterline. As such the overall lot coverage is 8% or 400 square feet greater than the code requirement."

Staff: The subject property is unique in the fact that it begins to narrow the closer you get to the road. This requires any structures to be built further into the 200-foot shore land in order to meet street and property line setbacks. Per the application, additional impervious surfaces were created in order to provide emergency access to the single-family dwelling. The overall size of the parcel, and the unique shape, can make development challenging.

- (b) **Special conditions and circumstances do not result from the actions of the applicant.**

Applicant: "This variance request is a result of the existing tax lot size and shape. If the lot shape was non-triangular the proposed ADU/Garage could be moved to the east farther in order to place some of the impervious areas outside the 200-ft setback from the lake. In this way the project would have met the county requirements and provided an access around the ADU to the remainder of the lot. This variance does not result in the creation of special conditions or circumstances."

Staff: The applicant acquired the subject property on September 28, 2016, via Warranty Deed, Instrument No. 896224, recorded on October 11, 2016. Since the time of acquisition, there is no indication that the applicant has altered the lot's size, shape, or topography. The applicant has no control over the unique shape of the property that is causing structures to be pushed further into the 200-foot shoreland due to the property narrowing closer to the road.

- (c) **The granting of the variance is not in conflict with the public interest in that it will not be detrimental to the public health, safety, or welfare, or materially injurious to properties or improvements in the vicinity of the subject parcel or lot.**

Applicant: "The proposed project is compatible with adjoining land uses. The construction of the garage/adu does not limit access to neighboring lot for emergency or fire vehicles. The position of the proposed garage/adu provides access for emergency vehicles to the existing home. The variance will be for construction of additional impervious driveway area roughly 190 feet from the lake. The stormwater management plan will address treatment and flow control for the stormwater generated by the proposed impervious areas."

Staff: A comment was received from Idaho Department of Environmental Quality expressing the importance of limiting impervious surfaces in the areas of surface water in order to protect water quality by limiting the amount of direct stormwater runoff into lakes. A stormwater management plan was submitted to and approved by the Bonner County Engineering Department during the review of the Building Location Permit related to this variance, File #BLP2025-0638.

No other agency or public comments were received indicating this project would be in conflict with the public interest.

Public Notice & Comments

At the time this Staff Report was written, two public responses were received with "No Comment".

Staff Review Summary:

The applicant acquired the subject property on September 28, 2016, and there have been no apparent modifications to the lot's size, shape, or topography since that time. The unique shape of the lot and the narrowing the closer you get to the road can make development challenging in the fact that in order to meet street and property line setbacks, structures need to be located closer to the shoreline.

Comments were received from the Idaho Department of Environmental Quality expressing the need to protect the water quality by limiting impervious surfaces. To mitigate these concerns, the applicants submitted a stormwater management plan that was reviewed and approved during the review of the associated Building Location Permit. No other comments were received from the public or any agencies indicating this proposal would be in conflict with the public interest.

CONCLUSIONS: Based on the foregoing findings, the following conclusions are adopted. The proposed administrative variance **is** in accord with the purposes of Title 12. This action does not result in a taking of private property. The action that could be taken to obtain the administrative variance is to complete the Conditions of Approval as adopted.

1. This proposal was reviewed for compliance with the criteria and standards set forth at Sections 12-233 and 12-234, Bonner County Revised Code, storm water management criteria and standards set forth in Chapter 7, Title 12, Bonner County Revised Code, and variance criteria and standards set forth at Section 67-6516, Idaho Code.
2. Conditions apply to the property that **do not** apply generally to other properties in the same zone or vicinity, which conditions are a result of lot size, shape, topography, or other circumstances over which the applicant has no control.
3. Special conditions and circumstances **do not** result from the actions of the applicant.
4. The granting of the variance **is not** in conflict with the public interest in that it **will not** be detrimental to the public health, safety, or welfare, or materially injurious to properties or improvements in the vicinity of the subject parcel or lot.

Conditions of Approval:

1. Only the development highlighted on the site plan has been reviewed for variance standards. All other development shown must comply with Bonner County Revised Code.
2. This variance shall not supersede any deed restrictions.

NOTE: Any determination made by the Planning Director in the administration of the provisions of this title may be appealed to the Board by paying the required fee and notifying the Planning Director in writing of the intent to appeal within ten (10) working

days from the date of the determination. Within ten (10) working of receipt of an appeal, the Planning Director shall schedule a meeting with the Board to hear the appeal and shall provide written notice to the appellant of the time and place of the meeting. The Planning Director and appellant shall be provided an opportunity to present the relevant issues to the Board at that meeting. The appellant bears the burden of proof and may be responsible for costs incurred for producing such proof, including engineering or surveying documents for other evidence. The Board's decision shall be final, and further recourse of the appellant shall be as provided by Idaho Code. If no appeal to the Board is filed, the Planning Director's decision shall be deemed final. (BCRC 12-261)

Following any final decision concerning a site-specific land use request, the applicant has a right to request a regulatory taking analysis pursuant to Section 67-8003, Idaho Code (Idaho Code §67-6535(3)).



Thank you for the opportunity to comment on the requested impervious surface coverage variance VA0015-25. Limiting impervious surface coverage in the areas near surface water bodies helps protect water quality by limiting the amount of direct stormwater runoff into streams and lakes that can carry sediment and other contaminants into surface water. While an individual variance may have minimal localized impacts, the cumulative effects of multiple variances that result in increased impervious surfaces near surface water within the watershed can be expected to have a negative impact on water quality over time. DEQ recommends maintaining the limits in established codes wherever possible, and considering individual variances carefully for very unique situations.



NLI does not object to the impervious surface coverage variance, however changes to the electrical service may need to be made to ensure the project conforms to BCR

We need at least 36" of working space around the exiting meter base, where NLI owns and maintains the electric meter.
We request more information from the landowner to determine if there will be adequate working space between the proposed structure.



If this adequate working space is available, NLI is not opposed to the project.
If there is not adequate working space around the existing meter base, we request that the governing body / director condition the approval of the variance so the land could be moved outside of the side yard setback and onto the side of the proposed ADU.


